Sub: Office of the Regional Administrator, Mahe - Expenditure sanction towards the Purchase of Medicines from Government of India Undertaking Firms for Govt. General Hospital, Mahe - Revalidation/Corrigendum - Orders - Issued.

Whereas expenditure sanction towards the purchase of Medicines was accorded vide Order 1st cited to incur an expenditure of **Rs.10,19,044/-** in the budget of the financial year 2017-18. Out of the amount sanctioned therein, an amount of **Rs.6,14,423/-** only was booked by the Deputy Director, Govt. General Hospital, Mahe during the financial year 2017-18 under the Head of Account shown in the sanction order due to paucity of funds.


2. Whereas expenditure sanction towards the purchase of Medicines was accorded vide Order 2nd cited to incur an expenditure of **Rs.5,52,927/-** in the budget of the financial year 2017-18. Due to paucity of funds, no expenditure was booked by the Deputy Director, Govt. General Hospital, Mahe during the financial year 2017-18 under the Head of Account shown in the sanction order.

3. Whereas expenditure sanction towards the purchase of Medicines was accorded vide Order 3rd cited to incur an expenditure of **Rs.2,59,823/-** in the budget. Due to paucity of funds, no expenditure was booked by the Deputy Director, Govt. General Hospital, Mahe during the financial year 2017-18 under the Head of Account shown in the sanction order.

4. Whereas since the Heads of Account under which the original sanction order accorded are inoperative during the current financial year owing to the merger of Plan & Non-Plan Heads of Account, Revalidation/Corrigendum to the original sanction order has been issued vide order 4th cited to enable the Deputy Director, Govt. General Hospital, Mahe to book the balance amount during the current financial year.

5. The Deputy Director, Govt. General Hospital, Mahe, is now seeking modification to the Order 4th cited. Therefore, in supersession of the Order 4th cited, the expenditure sanction orders vide ref. 1st and 2nd cited are hereby revalidated for the current financial year and Corrigendum to the orders vide ref.1st to 3rd cited are issued as per Annexure to this Order.

6. All other terms and conditions stipulated in the original expenditure sanction orders will remain unaltered.
