ORDER

Sub: Office of the Regional Administrator, Mahe –COVID-19
– Establishing Containment Zone at CHC Quarters,
Palloor where COVID-19 Positive case reported - Orders
-Issued.

In view of reporting of COVID-19 positive case at Community Health Centre Quarters, Palloor situated in Pandakkal Revenue Village on 08-09-2020, the entire quarters has been declared as Containment Zone with immediate effect.

The following directives/restrictions/conditions shall continue to prevail in the said Containment Zone until further orders for the prevention and containment of the COVID-19:

- All vehicular movement, movement of public in and out of the Containment Zone shall be restricted. Movement of people can be allowed only for medical emergencies and to maintain delivery of essential goods and services (Action: SP, Mahe)
- All shops and establishments shall remain closed within the Containment Zone (Action: Commissioner, Mahe Municipality, Mahe)
- Home delivery of essential commodities shall be ensured through volunteers in the said Containment Zone (Action: Officer-in-Charge of Containment Zone (Mobile: 9746197811)).
- All the entries to the Containment Zone shall be guarded by the Police with clear entry and exit points. A register shall be maintained by the Police for recording the details of persons moving in and out of the perimeter of the Containment Zone. (Action: SP, Mahe)
- The Medical Officer of the Government General Hospital, Mahe shall carry out house to house screening within the Containment Zone by a team of Health Officials and clinical management of all cases as per protocol. (Action: DD (Health))
- Fire Service Department shall make necessary arrangements for disinfecting the entire Containment Zone. (Action: Station Officer, Fire Service Department, Mahe)

- Contact tracing team shall be deployed which shall identify primary and secondary contacts of the identified case. The contacts so identified shall be restricted to strict quarantine and their swabs to be sent for testing as per protocol. (Action: DD (Health))
- Deputy Tahsildar designated for Pandakkal area shall be the Officer –in- Charge of the said Containment Zone and shall ensure that all Lockdown restrictions are strictly imposed in the said Containment Zone along with directions issued in this order.

Appropriate action and continuous monitoring by the respective teams shall be ensured in the Containment Zone so as to effectively control the spread of the COVID-19.

Any dereliction or disobedience or any attempt of non-compliance of this order will be viewed seriously and legal action as per provisions of Disaster Management Act, 2005 and other relevant laws under force will be initiated.

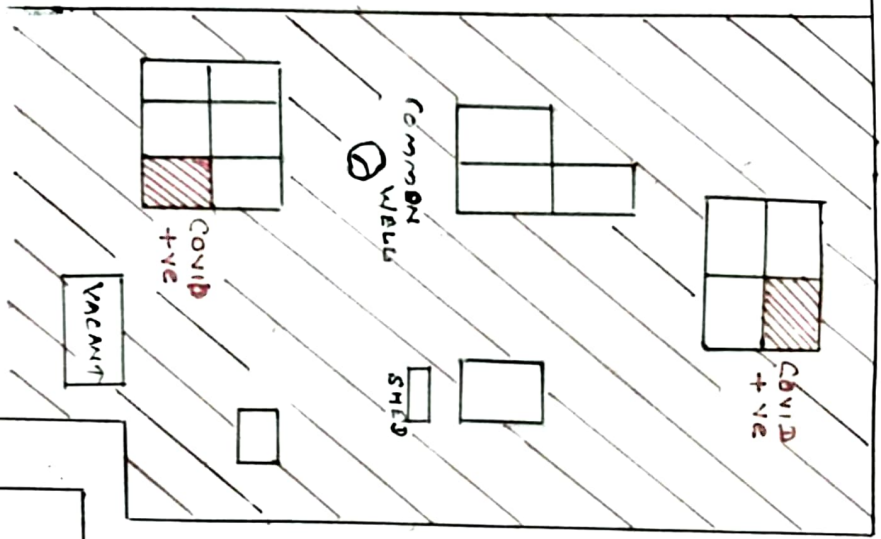
