OFFICE ORDER

The main temple and its premises will remained closed and all the activities performed by the Trust and G.P. Trilokpur for the celebration of fair are also cancelled/banned as under with immediate effect till further order:-

1. The auctions of all shops/plots for Chettra Navratra Mela, 2020 at Trilokpur are cancelled.
2. All the booking of Yatri Niwas/Dharamshalas etc. by Trilokpur Temple Trust is cancelled.
3. All the Tenders awarded by Trilokpur Temple Trust in connection with fair are also cancelled.
4. All the Bhandaras run by the Trilokpur Temple Trust or any individual are totally banned.
5. The District Police Authorities will keep continuous vigil and ensure strict compliance of above mentioned directions.
