

"OFFICE ORDER"

As per the direction contained in fax message No. Div.Commr.(SML)/PS/Misc./2020 dated 16th May, 2020 received from the Ld. Divisional Commissioner, Shimla Division, Shimla, near about 1030 people of Uttrakhand State stranded in Himachal Pradesh and about 350 people of HP who are stranded in Uttrakhand are to be evacuated. The Uttrakhand state will ply their buses upto Paonta Sahib to carry the stranded people of HP and will take back the people of their State from Paonta Sahib and for this purpose adequate buses will be plied by the Uttrakhand State on 18th May, 2020.

In order to ensure proper arrangement of arrival and departure of the people of both the States, Sh. Kapil Tomar, Tehsildar, Paonta Sahib (M.No. 98163-22767) will be the Nodal Officer for the stranded people of HP moving from Uttrakhand to this State. Sh. Hem Raj Kashyap, Tehsildar, Kamrau (M.No. 94180-25448) will be the Nodal Officer for the people of Uttrakhand stranded in this State and who are to move to Uttrakhand. These both officers are directed to liaise with the HRTC and ensure the movement of these stranded people properly. Also, proper norms of sanitization of buses and wearing mask by every people who boards in the bus must be ensured.


