PARTIAL MODIFICATION OF ORDER DATED 09<sup>TH</sup> JUNE, 2020

This is in continuation of this office order of even No. dated 09<sup>th</sup> June, 2020 issued by the undersigned regarding cordoning off the area of Gram Panchayat Kala-Amb and Trilokpur as Containment/Buffer Zone. As per report of Sub-Divisional Magistrate, Nahan furnished vide letter No. SOK/COVID-19/SDM/N/2020-925 dated 11<sup>th</sup> June, 2020, some area of Gram Panchayat, Kala-Amb has also been recommended to be declared as Containment Zone. Hence, the following area of Gram Panchayat, Kala-Amb has been included in the containment zone area which has been cordoned off vide aforementioned order of this office:- **(1) Entire "Gadria Basti" in Sub-Village Khaari (under Revenue Village Ogli) starting from the house of Sh. Madan Lal & ending at the house of Sh. Guman Singh (2) The area parallel to the Kala-amb Sadhaura Road on the Himachal side at Sub-Village Khaari (under Revenue Village Ogli) comprising of factory units namely (i) M/s Orison Pharma International (ii) M/s Rica Enterprises (iii) M/s Aqua Paretral (iv) M/s Primis Pharmaceuticas (v) M/s Sangsharmann Plast Pvt. Ltd. (vi) M/s Nixi Laboratories Pvt. Ltd.**

All conditions/directions issued vide order dated 09<sup>th</sup> June, 2020 shall remain enforced and unchanged.
