ORDER

Whereas, the entire area of Village Bag, Gram Panchayat Bag-Pashog & adjoining/contiguous area of Village Kangar-Dharyar, Tikkri Pajreli, Ghargon Plashon and Village Poghat of Gram panchayat Bag-Pashog was cordoned off vide this office order of even No. dated 06th June, 2020 due to one corona positive case found in village Bag-Pashog, Tehsil Pachhad, District Sirmaur(HP).

Whereas, the Sub-Divisional Magistrate, Pachhad, District Sirmaur has informed the undersigned vide letter No. 03-SDM-PD (Covid-19)/2019 dated 04th July, 2020 that no corona positive case in aforementioned areas was detected during last one month and accordingly the request to scale down the containment operation in aforementioned areas has been made.

Whereas, as per the guidelines of the Ministry of Health & Family Welfare, Govt. of India regarding containment zone, the operation will be scaled down if no secondary laboratory confirmed COVID-19 case is reported from the geographic quarantine zone for at least four weeks after the last confirmed test has been isolated and all his/her contacts have been followed up for 28 days.

In view of this, I am satisfied that above mentioned areas of Gram Panchayat Bag-Pashog, Tehsil Pachhad do not require to be continuing under Hotspot/Containment Zone/Buffer zone.

Therefore, I, Dr. R.K. Pruthi, IAS, District Magistrate, District Sirmaur in exercise of the powers vested in me under Section 144(1)(5) of Cr.P.C. 1973 do hereby order and direct that:-

1. The containment operation in Village Bag, Gram Panchayat Bag-Pashog and areas of Village Kangar-Dharyar, Tikkri Pajreli, Ghargon Plashon and Village Poghat of Gram Panchayat Bag-Pashog as ordered vide this office order of even No. dated 06th June, 2020, is scaled down.



2. The order dated 29th June, 2020 of the Ministry of Home Affairs, Govt. of India, directions dated 30th June, 2020 of the Govt. of H.P. and the order dated 30th June, 2020 issued by this office shall be complied with by all concerned in letter and spirit.
3. The movement of individual(s) shall remain strictly prohibited between 09:00 PM to 05:00 AM (Night Curfew) throughout the District except for essential activities.
4. All orders issued by this office from time to time to contain the Covid-19 shall remain enforced and all concerned shall ensure compliance of these orders.
5. All persons above 65 years of age and persons with co-morbidities, pregnant women and children below the age of 10 years, shall stay at home, except for essential and health purposes.
6. Wearing of face cover is compulsory in all public and work places.
7. Spitting in public & work places shall be punishable with fine, as may be prescribed in accordance with laws, rules or regulations by the local authority.
8. The marriage related gathering shall ensure social distancing and the maximum number of guests allowed shall not be more than 50.
10. The funeral/last rites related gathering shall ensure social distancing and the maximum numbers shall not be more than 20.
11. All the shop keepers if any, in the aforementioned areas shall ensure minimum six feet distance (2 gaz ki doori) among the customers. No shop keeper shall undertake sale to the customers without wearing face mask.

Any person contravening these orders shall be liable for prosecution under Section 269,270 and 188 IPC and Section 51 to 60 of Disaster Management Act, 2005.

This order shall come into effect immediately from the date of issuance.
