No. SRM-DRA (DDMA) COVID-19/2020- Dated, Nahan, 12th July, 2020

ORDER

Whereas, the Sub-Divisional Magistrate, Nahan, District Sirmaur, H.P. has informed this office vide letter No. SOK/COVID-19/SDM/N/2020-1148 dated 12th July, 2020 that one person living at Village Kheda, Revenue Village Devni, Patwar Circle, Moginand, Tehsil Nahan, District Sirmaur (HP) has been tested corona positive. In order to follow up this corona positive case, the Sub-Divisional Magistrate, Nahan has recommended the following area to be declared as Containment Zone and Buffer Zone:-

Sr. No.	Name of Gram Panchayat	Containment Zone	Buffer Zone
1.	Devni	Comprising of total 12 residential houses of Sub Village Kheda and open vacant & agricultural fields with following limits: The containment zone is sandwiched between the River Markanda (left bank area) in the North East and road leading from Village Konthron to Village Nagal Suketi & the Reserve Forest area in the South West. Containment zone is separated by a Khad flowing under the bridge on above road in the South East and open fields to agricultural fields on the North West. The length of the containment zone along the above road is about 400 meters starting from Rain Shelter & culmination at Sanju's House and along the left bank of the river Markanda is about 1 Km starting from confluence of above khad & river Markanda and culmination at Ramkaran's agricultural field. The width of this containment zone on the South East is about 1 Km starting from the rain shelter on the above HPPWD Road and culminating at the above confluence. The width on the North West

		is about 500 meters starting from the house of Sanju and culminating at the agricultural field of Ramkaran etc. on the river bank	
2.	Bikrambag		Village Konthron

Whereas, keeping in view the positive testing of one case in Village Kheda, Gram Panchayat, Devi, Tehsil Nahan and subsequent recommendation of the Sub-Divisional Magistrate, Nahan, District Sirmaur (HP), the above mentioned area needs to be cordoned off as containment zone and to be declared as buffer zone for containing the spread of infection.

Whereas, I am satisfied that aforementioned area is required to be cordoned off immediately to contain the spread of infection of the said virus as recommended by the Sub-Divisional Magistrate, Nahan, District Sirmaur(H.P.).

Whereas, it is a case of Health Emergency and the circumstances are so grave that serving of notice upon all persons residing in the area mentioned above is not practicable or possible at this juncture and therefore, it is necessary and expedient to proceed ex-parte under Section 144(2) of Cr.P.C. 1973.

Therefore, I, Dr. R.K. Pruthi, IAS, District Magistrate, District Sirmaur in exercise of the powers vested in me under Section 144(1)(2) of the Cr.P.C. 1973 do hereby order and direct that:-

- **The above mentioned area of Village Kheda, Gram Panchayat, Devni, Tehsil Nahan recommended to be declared as containment zone is cordoned off and no person residing in the said area shall be allowed to assemble, gather or congregate at any place of the said area and they shall remain inside their houses except in case of emergency. Besides, the area of Village Konthron, Gram Panchayat, Bikrambag, Tehsil Nahan as mentioned above is declared as buffer zone.**


- No person shall participate; organize any function(s), demonstration(s), meeting(s), procession(s), rally, picketing, workshop(s), community or religious events within the limits of the containment zone mentioned above.
- The shop(s) if any, in the aforementioned area shall remain closed except Chemist Shop.
- All essential service provider(s) residing in Village Kheda, Revenue Village, Devni shall attend their duties and shall take all necessary precautions.
- All essential commodities shall be supplied door to door inside the containment area for the convenience of the people with the assistance of Pradhans/Up-Pradhans of concerned Gram Panchayats.
- This order shall not apply on officer on Magisterial duty, Police personnel, officers/officials involved in enforcement of these orders and other authorized person(s)/vehicle(s) engaged in supplying of essential commodities and health services.
Sanitization in containment area on regular basis shall be carried out by the BDO, Nahan.
- The Chief Medical Officer, District Sirmaur shall ensure to keep a medical team constituted/stationed for this area round the clock to keep strict vigil on the health of the people.
- The Superintendent of Police, District Sirmaur shall ensure to keep a strict vigil on the enforcement of containment order in the aforementioned area.

Any person contravening these orders shall be liable for prosecution under Section 269,270 and 188 IPC and Section 51, 54 and 56, of the Disaster Management Act, 2005.

13. The Naib-Tehsildar, Nahan, District Sirmour shall perform as Duty Magistrate for this containment area and he shall ensure proper implementation of this order and supply of essential commodities inside the above mentioned area.
14. The Block Development Officer, Nahan for information and necessary action.
14. All District Level Govt. Heads of Offices for information & necessary action.
15. The DPRO, District Sirmour at Nahan for wide publicity.

16. The DIO, DC Office, District Sirmaur at Nahan for uploading the order on official website of the District Administration.
17. The Pradhan/Up-Pradhan of concerned Gram Panchayat through BDO, Nahan for information and necessary action.
