**ORDER**

Whereas, the containment operation was scaled down in areas of Ward No. 1 & 2 of M.C. Paonta Sahib vide this office order dated 12<sup>th</sup> July, 2020 which was cordoned off as containment zone and buffer zone vide order dated 26<sup>th</sup> June, 2020.

Whereas, the containment operation in house No. 13/1, Ward No.1 of Sh. Sampuran Singh at Badripur, Paonta Sahib was kept enforced as recommended by the Block Medical Officer, Rajpur and Sub-Divisional Magistrate, Paonta Sahib.

Whereas, the Sub-Divisional Magistrate, Paonta Sahib has recommended vide his letter No. SDM-Paonta-SDK(COVID-19)2020 dated 23<sup>rd</sup> July, 2020 that since the area is now Covid free zone and therefore, the containment operation in house No. 13/1, Ward No.1 of Sh. Sampuran Singh at Badripur, Paonta Sahib may be scaled down.

Whereas, I am satisfied that keeping in view the recommendation of Sub-Divisional Magistrate, Paonta Sahib referred to above, the containment operation in aforementioned Ward No.1 is not required for longer period and prescribed follow up period of 28 days has also been completed.

Therefore, I, Dr. R.K. Pruthi, IAS, District Magistrate, District Sirmaur in exercise of the powers vested in me under Section 144(1)(5) of Cr.P.C. 1973 do hereby order and direct that:-

1. The containment operation in **house No. 13/1, Ward No.1 of Sh. Sampuran Singh at Badripur, Paonta Sahib** as recommended by the Sub-Divisional Magistrate, Paonta Sahib is scaled down.
