CORRIGENDUM

This is in continuation of this office order of even No. dated 22nd July, 2020 issued by the undersigned regarding cordoning off some area of Ward No. 4 of Village & Gram Panchayat Kothia Jajar, Tehsil Rajgarh as containment zone and area of ward No. 2 of N.P. Rajgarh and Village Dharoti & Choken of GP Kothia Jajar, Tehsil Rajgarh as buffer zone. The Sub-Divisional Magistrate, Rajgarh has informed the undersigned vide his letter No. 7-RAJ-SDM/ (COVID-19)2020-330 dated 01st August, 2020 that the Duty Magistrate,-cum-Tehsildar, Rajgarh and Medical Officer I/C, CH, Rajgarh have reported that all 38 samples of the contacts of two COVID Positive cases were tested and all have been found negative. Further, it has been reported that they have completed Active Case Finding (ACF) in containment zone in Ward No. 4 of Gram Panchayat Kothia Jajar alongwith all wards of Rajgarh and no case of ILI and SARI was found. Therefore, it has been requested that the boundaries of the containment zone of Ward No. 4 of Village & Gram Panchayat Kothia Jajar, Tehsil Rajgarh may be re-defined as under:-

1. "House of Sh. Pramod and house of Sh. Krishan Sharma below Pramod's house on valley side of Rajgarh-Tikker road".
2. "House of Sh. Desh Raj Saklani and Seema Sharma on the hill side of Rajgarh-Tikker road".

Keeping in view the contents of the report of the Sub-Divisional Magistrate, Rajgarh and Para 3 of the Micro Plan for Containing Local Outbreak of COVID-19, the boundaries of the containment zone are hereby re-defined as under:-

1. "House of Sh. Pramod and house of Sh. Krishan Sharma below Pramod's house on valley side of Rajgarh-Tikker road".
2. "House of Sh. Desh Raj Saklani and Seema Sharma on the hill side of Rajgarh-Tikker road".

Rest of the conditions of the order dated 22nd July, 2020 shall remain unchanged.
