CORRIGENDUM


This is in continuation of this office order dated 23rd July, 2020 & subsequent order dated 30th July, 2020 issued by the undersigned regarding cordoning off some area of Ward No. 3, 4 and 6 of Gram Panchayat, Dadahu, Tehsil Dadahu as containment zone/buffer zone. The Sub-Divisional Magistrate, Nahan has informed the undersigned vide his letter No. SOK/COVID-19/SDM/N/2020-1312 dated 08th August, 2020 that Naib Tehsildar, Dadahu on the comments of the Medical Officer, Incharge Civil Hospital, Dadahu has requested to re-define the limits/boundaries of containment zone ordered vide aforementioned orders. Since, no more persons have been tested Covid-19 positive in the containment zone, therefore, the limits of containment zone of GP Dadahu may be re-defined as under:-

1. Meat shop and House of Sh. Gurmeet Singh (person tested positive earlier.
2. Ground floor of the building of Sh. Punit Sood where the Dhaba of Sh. Ravinder (person tested positive) is located.

Keeping in view the recommendation of the Sub-Divisional Magistrate, Nahan, the area of containment zone is hereby re-defined as under:-

- 1. Meat shop and House of Sh. Gurmeet Singh (person tested positive earlier.**
- 2. Ground floor of the building of Sh. Punit Sood where the Dhaba of Sh. Ravinder (person tested positive) is located.**

Rest of the conditions of the order dated 23rd July, 2020 shall remain unchanged.
