ORDER

Whereas, the entire Aadinath Complex of Yashwant Vihar Colony, Ward No. 2 of MC Nahan and remaining area of said Ward was cordoned off as containment/buffer zone vide this office order dated 9th July, 2020 due to one corona positive case found in Yashwant Vihar Colony, Nahan, Tehsil Nahan, District Sirmaur(HP).

Whereas, the Chief Medical Officer, District Sirmaur has informed this office vide his letter No. HFW-N (Covid-19) (Gen)/2020-1633 dated 7th July, 2020 that one Covid-19 positive case was found in Yashwant Vihar Colony, Nahan who has been discharged from DCCC after his sample was tested negative. No new case was detected in 10 primary/secondary contact tracing of above case. Therefore, he has requested to scale down the containment operation in the said area.

Whereas, as per the guidelines of the Ministry of Health & Family Welfare, Govt. of India regarding containment zone, the operation will be scaled down if no secondary laboratory confirmed COVID-19 case is reported from the geographic quarantine zone for at least four weeks after the last confirmed test has been isolated and all his/her contacts have been followed up for 28 days.

In view of the report of the Chief Medical Officer, District Sirmaur and relevant guidelines, I am satisfied that above mentioned area of Yashwant Vihar Colony, Nahan, Ward No. 2 of MC Nahan, Tehsil Nahan do not require to be continuing under Containment Zone/Buffer zone.

Therefore, I, Dr. R.K. Pruthi, IAS, District Magistrate, District Sirmaur in exercise of the powers vested in me under Section 144(1)(5) of Cr.P.C. 1973 do hereby order and direct that:-

1. The containment operation in the above mentioned area of Yashwant Vihar Colony, Ward No.2 of MC Nahan as ordered vide this office order dated 9th July, 2020, is scaled down.
2. The order dated 29th July, 2020 of the Ministry of Home Affairs, Govt. of India and guidelines for Phased Re-Opening (Unlock-3) shall be complied with by all concerned in letter and spirit.

3. All orders issued by this office from time to time to contain the Covid-19 shall remain enforced and all concerned shall ensure compliance of these orders.

4. All persons above 65 years of age and persons with co-morbidities, pregnant women and children below the age of 10 years, shall stay at home, except for essential and health purposes.

5. Wearing of face cover is compulsory in all public and work places.

6. Spitting in public & work places shall be punishable with fine, as may be prescribed in accordance with laws, rules or regulations by the local authority.

7. The marriage related gathering shall ensure social distancing and the maximum number of guests allowed shall not be more than 50.

8. The funeral/last rites related gathering shall ensure social distancing and the maximum numbers shall not be more than 20.


9. Social distancing norms i.e. minimum 6 feet (2 gaz ki doori) shall be followed by all.

Any person who is found violating these orders he/she shall be liable for prosecution under Section 269,270 and 188 IPC and Section 51 to 60 of Disaster Management Act, 2005.

This order shall come into effect immediately from the date of issuance.
