ORDER

Whereas, the following area of Ward No. 04 of Nagar Panchayat, Rajgarh, Tehsil Rajgarh, District Sirmaur was cordoned off as containment/buffer zone vide this office order dated 20.08.2020 due to corona positive case detected in the said area:-

Whereas, the Sub-Divisional Magistrate, Rajgarh, District Sirmaur has reported vide letter No. 8-Raj/SDM/COVID-19/2020-1690 dated 15<sup>th</sup> September, 2020 that as per report of Sr. Medical Officer, Rajgarh, all primary and secondary contacts of positive case have been tested as negative and no new case of COVID-19 has been detected or identified in the above mentioned area during this period. Also, the active case finding campaign has been conducted thoroughly. Further, it has been requested that containment operation in above mentioned area may be scaled down as no new Covid-19 positive case has been found in the said area.

In view of this, I am satisfied that above mentioned area of W.No.4 of Nagar Panchayat, Rajgarh, Tehsil Rajgarh, District Sirmaur do not require to be continuing under Containment Zone/Buffer Zone.

Therefore, I, Dr. R.K. Pruthi, IAS, District Magistrate, District Sirmaur in exercise of the powers vested in me under Section 144(1)(5) of Cr.P.C. 1973 do hereby order and direct that:-

1. The containment operation in containment area mentioned above including restrictions in buffer zone as recommended by the Sub-Divisional Magistrate, Rajgarh as well as Sr. Medical Officer, Rajgarh is scaled down.

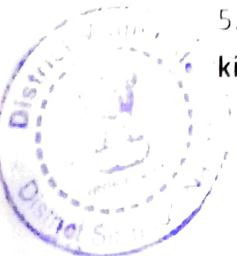
2. The order dated 29<sup>th</sup> August, 2020 of the Ministry of Home Affairs, Govt. of India and guidelines for Phased Re-Opening (Unlock-4) and order dated 31.08.2020 of the Govt. of H.P. shall be complied with by all concerned in letter and spirit.

All orders issued by this office from time to time to contain the Covid-19 shall remain enforced and all concerned shall ensure compliance of these orders.

4. All persons above 65 years of age and persons with co-morbidities, pregnant women and children below the age of 10 years, shall stay at home, except for essential and health purposes.

5. Wearing of face cover and maintaining social distancing norms (2 gaz ki doori) are compulsory and these norms shall be followed by all.

6. Spitting in public & work places shall be punishable with fine, as may be prescribed in accordance with laws, rules or regulations by the local authority.

If any person is found violating these orders, he/she shall be liable for prosecution under Section 269,270 and 188 IPC and Section 51 to 60 of Disaster Management Act, 2005.

This order shall come into effect immediately from the date of issuance.
