
ORDER

The Chief Medical Officer, District Sirmaur at Nahan vide his office letter No. HFW-N (Covid-19)/2021- Nil dated 20th April, 2021 and Sub-Divisional Magistrate, Pachhad at Sarahan, District Sirmaur (H.P) vide his office letter No. Nil Dated 20th April, 2021; have informed that keeping in view the sharp increase of Covid-19 positive cases in the Akal Academy at Baru Sahib, there is a need to establish a Dedicated Covid Care Center (DCCC) at Baru Sahib, so that Covid confirmed cases could be kept and treated in the said center. It has further been reported that the entire Akal Academy Hospital Building at Baru Sahib is recommended to be a notified Dedicated Covid Care Center.

Therefore, in view of the sharp increase in positive cases of Covid-19 at Baru Sahib District Sirmaur (H.P), it is expedient to create a Dedicated Covid Care Center (DCCC) at Baru Sahib.

Therefore, I, Dr. R.K. Pruthi, IAS, District Magistrate, District Sirmaur at Nahan in exercise of the powers vested in me vide order No. NHMHP-IDSP/1/2020-IDSP-Section- National Health Mission-HP-3957 dated 22-06-2020 issued by the Additional Chief Secretary (Health) to the Govt. of H.P., hereby notify the **entire Akal Academy Hospital Building at Baru Sahib as Dedicated Covid Care Center to keep and treat Covid-19 positive cases.**

The Senior Medical Officer-cum-(incharge) of Civil Hospital, Rajgarh will monitor and supervise Dedicated Covid Care Center (DCCC) at Baru Sahib on routine basis.
