EXECUTIVE ORDER

WHEREAS, information has been received that there may be an influx of illegal migrants to the state of Arunachal Pradesh in the form of labourers, carpenters, masons, etc. from other parts of the country in general and Assam in particular due to the recent updations of the National Register of citizens by the state of Assam.

WHEREAS, there is every likelihood that these illegal migrants may try to enter into the territorial jurisdiction of Lower Dibang Valley District.

Therefore, it is hereby ordered that Inner Line Permit shall be issued to the Non-APSTs after proper verification of documents related to Domicile/Identity proof and Police Verification Report from the native Police Stations of the applicant(s) by Officer-in-Charge of ILP Section. In the absence of any of the above documents no Inner Line Permit shall be issued.

Further, intensive Police Checking of ILP shall be carried out by the Officer-in-Charge of the respective Police station within Lower Dibang Valley District with immediate effect and Non- APSTs staying within Lower Dibang Valley District without ILP and other proper documents should immediately be identified and deported beyond the Inner Line jurisdiction.

All construction agencies / local contractors and business enterprises engaged in infra-structural Projects or otherwise within the District should ensure that Non-APST labourers engaged in any work must have valid documents to prove their domicile along with proper Police Verification, failing which necessary legal action shall be initiated against defaulters.

In case of issuance of Temporary ILP, the EAC (ILP), Circle Officer i/c Shantipur Check Gate and Police Officer-in-Charge of Shantipur Check Gate shall make an enquiry of the exact nature and purpose of visit by an applicant(s), verify the Identity of the Local sponsorer if any and ensure the exit of such an applicant(s) after the purpose of visit is completed.

A daily list of Temporary ILPs issued should be submitted to the Office of the EAC ILP and the Superintendent of Police.

This is for strict compliance by all concerned.




