BLOs at column 5 & Supervisors at column 7 are directed to handover all the relevant documents viz Electoral Roll, BLO Register etc. pertaining to their designated locations to the newly appointed Supervisors/BLOs in proper receipt. A copy of handing/taking over charges should be submitted to this office by indicating the latest mobile/contact number of newly appointed Supervisor & BLO.

## BLOs should go through the instruction as per following:-

House to House Field Verification:- (i) For field verification, the BLOs will be given a pre filled BLO register containing the details of existing electors in their respective part for H2H field visit and to get the said details verified from the head of the family. In addition to that, BLOs will collect the following information.

- a) Un-enrolled eligible citizens (eligible on 01.01.2018)
- b) Prospective voters (eligible on 01.01.2019)
- c) Multiple entries / dead electors/ Permanently Shifted Electors (details may be given in remarks column of pre-filled BLOs register)
- d) Correction in the ER entries. (details may be given in remarks column of pre-filled BLOs register)
   Additional Task for BLOs-
- e) Unenrolled Persons with Disability (PwDs) (eligible on 01.01.2018). List of Disabled persons enclosed herewith for ready reference.
- f) Existing Persons with Disability (PwDs) in electoral roll. List of Disabled persons enclosed herewith for ready reference.
- g) Distribution of New PVC EPIC of replacement of B/W EPIC and Special Summary Revision w.r.t. 1-1-2018

On completion of field verification, each BLO shall furnish the certificate to the Electoral Registration Officer through Supervisor concerned, to the effect that details in respect of all the Seven items have been collected 100% without any left over.

Further, newly appointed BLOs are directed to ensure that no dead voters and shifted voters are included in the Electoral Roll and only eligible voters have been enrolled. The BLOs are responsible for the part of Electoral Roll assigned to them as well as EPIC/Claims and objections verification during on Special Summary Revision of Photo Electoral Roll and other revision and EPIC works.

Further, Supervisors are directed to verify at least 5% of each BLO's work under him, which will be field verification. They should ensure that no dead voters and shifted voters are included in the Electoral Roll and only eligible voters have been enrolled. The supervisory officers are responsible for the part of Electoral Roll assigned to them as well as EPIC/Claims & objections verification.

All BLOs, ERO's and AERO's representatives are directed to receive Pre Revision activities materials immediately from DEO's office, Roing from 15<sup>th</sup> May, 2018 during office hours.
