
ORDER

WHEREAS, the Election Commission of India vide its order No.437/6/1/ECI/INST/FUNCT/MCC/2019 dtd 10<sup>th</sup> Mar/2019 has issued instructions and restrictions in regard to printing and publication of election pamphlets, poster, etc., governed by the provisions of Section 127A of the Representation of People Act, 1951. No person shall print or publish, or cause to be printed or published, any election pamphlets or poster which does not bear on its face the names and addresses of the printer and the publisher thereof.

Therefore, No person shall print or cause to be printed any election pamphlet or poster, unless a declaration as to the identity of the publisher thereof, signed by him and attested by two persons to whom he is personally known, is delivered by him to the printer in duplicate, and unless, within a reasonable time after printing of the document, one copy of the declaration is sent by the printer, together with one copy of the document to the concerned authority.

The above restriction on the printing of election pamphlets, poster, etc., has been imposed under the law with a view to establishing the identity of Publishers and printers of such documents, so that if any such documents contains any matter or material which is illegal, offending or objectionable like appeal on ground of religion, race, caste, community or language or character assassination of an opponent, etc., necessary punitive or preventive action will be taken against the person concerned. These restrictions also sub serve the purpose of placing a check on the incurring of unauthorized election expenditure by political parties, candidates and their supporters in the printing and publication of election pamphlets, posters etc.

Therefore, all concerned are hereby informed and directed to comply with this order to ensure be free, fair, and transparent elections in the district.
