CIRCULAR

It is for general information to all concerned Shopkeeper of the L/Dibang Valley District that selling of SKO Oil in any shop(s) or premises without having the SKO trading licence issued by the competent authority is an offence under the Provisions of ESSENTIAL COMMODITIES Act 1955 or any other relevant control orders.

On enquiry, it has been learnt that some unauthorised Businessman or insider dealing from Shantipur(Assam) are supplying PDS SKO Oil in the District by getting entry through Shantipur Checkgate carrying 10 to 20 Ltrs capacity of plastic container through Tempo and Autorickshaw and selling at higher price inside the Lower Dibang Valley District at various location or areas. As a result, the Roing Police team had seized recently about 50 Ltrs (Fifty Ltrs) of PDS SKO from one unauthorised shopkeeper i.e. Shri Kudeswar Yadav of Roing Lower Market.

Therefore, all concerned are hereby directed not to sell SKO oil in the open market or any other premises if any person or Businessman caught doing such insider dealings shall be initiated strict action as per the provision of ESSENTIAL COMMODITIES Act) 1955 or any other relevant Control Orders.
