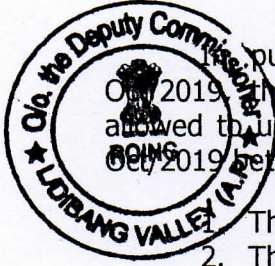

CIRCULAR



In pursuance of Govt. approval conveyed vide letter No.LM-328/2016/874 dtd. 3rd Oct/2019, The Brigadier Commander, 375 Composite Artillery Brigade, C/O 99 APO is hereby allowed to undertake Field firing approximately 30 Kms East of Hunli from 21st Oct/2019 to 25th Oct/2019 between 0700 hours to 1400 hours subject to following terms and conditions :-

1. The user should ensure that no damages be done to the forest area.
2. The movement of human/domestic animals/vehicle are prohibited in and around the firing area/jurisdiction.
3. All precautionary measures are to be strictly followed by the Army authority to ensure that no losses to human lives, property and animals take place.
4. The area should be cordoned off by displaying Red flag.
5. In the event of any mishap/casualties, the necessary compensation shall be borne by the Army authorities.

Therefore, all are requested not to let loose their domestic animals during the period of firing and to restrain pedestrian movement/visit within the Firing range area.
