2. General Household Category ( GHHHC) ration card holders of M/S D.V. Lamp No. II FPS Roing will be issued their ration quota on 12<sup>th</sup> and 13<sup>th</sup> of Dec'2019, through existing Booklet Ration Card(s) positively.
3. The Block Development Officer, Roing may kindly depute their officer/officials on 12<sup>th</sup> & 13<sup>th</sup> Dec'2019 for monitoring the issue of Rice on the specific Day.
4. The Food & Civil Supplies Officer/Officials will monitor on 09<sup>th</sup> & 10<sup>th</sup> Dec'2019 which will be issued through e-POS Machine.
