**ORDER**

In view of the emergency situation arising due to the threat of COVID-19, and as per lockdown announced by the Govt. of India and Govt. of Arunachal Pradesh, the following directions are issued for compliance of all concerned in Lower Dibang Valley district for a period of the next 21 days w.e.f. 000 hours of 25<sup>th</sup> March 2020.

1. Nakas to be made operational at Deopani and Meka Tinali to check vehicular movement.  
Action by :- S.P. Roing.
2. Plying of private vehicles (including all taxis/sumos/buses) is strictly restricted, except for movement to Medical or Market area for procurement of essential grocery items as per schedule in table attached. Private vehicles plying without valid reason to be seized by Police Dept. In coordination with DTO, Roing and FIR to lodged as per provisions. SP Roing is to provide police personnel with DTO, Roing.  
Action by :- SP Roing and DTO, Roing.
3. Monitoring of Nakas, Market Areas and other quarantine zone by Magistrates as per rooster to be updated in partial modification of earlier order.  
Action by :- EAC Judicial
4. All HODs to issue passes to their staff engaged for essential services in the district which should be kept at the bare minimum. The list of essential service will be as per the list issued by Ministry of Home, Govt. of India vide notification dtd. 24<sup>th</sup> March 2020 declaring complete lock down.  
Action by :- All HODs concerned.
5. All construction works to cease in the district engaging labourers and heavy machinery. DLEO to file FIR against any contractor or work agency, including BRO/NHIDCL/NHPC and Work agencies engaging labourers. All Dept. HoDs are directed to issue necessary direction to contractors to cease all works.  
Action by :- DLEO and all HoDs.
6. Operation of all business establishments in the district is hereby suspended, which shall include all restaurants including serving of takeaways except grocery shops and meat vendors in Roing market. The grocery/meat vendors will be open between 0900 hrs to 1200 hrs every day as per date provided for each village/area in the table and as per prescribed rate at prescribed quantities.
  - a) Lower Market will open on 26,28,30 March and 01,03,05,07,09,11, and 13 April 2020, Upper Market will open on 25, 27, 29, 31<sup>st</sup> March and 02,04,06,08,10,12 and 14<sup>th</sup> April 2020.
  - b) All Paan-ghumtis in different localities also to be closed down.
  - c) Necessary legal action of fine and suspension of license to be undertaken by Supdt (Tax & Excise).
  - d) Rate checking shall be undertaken by DF&CSO.
  - e) Only one individual per family from the villages are to be out during the period on scheduled days. Such an individual shall be carrying his EPIC Card and Aadhar Card for verification.

ADC, Dambuk, SDO Hunli, SDO Parbuk, SDO Paglam, CO Koronu and Desali to issue separate orders for respective jurisdiction.

Action by :- Supdt (T&E)/DFCSO/All Admin Officers.


7. All emergency services and uninterrupted telecom service to be ensured by all stakeholders in the district.  
Action by :- All concerned HoDs and private telecom operators.
8. All mining permits including operation of crusher units etc shall be suspended till the end of lock down period.  
Action by :- AMDO/DFO(T)

9. All business establishments requiring movement to Assam for procurement of essential items shall take permit from the office Supdt (T&E) with details of driver/vehicle no and items to be procured and place and supplier in Assam, in advance of 3 days for such movement. Permit for medicine to be purchased by Pharmacies shall be issued by DMO, Roing.
10. All recreational sports in general ground/badminton courts and other sports activities in general area i.e roads/parks/river banks is banned. All parks/Zoos etc are to closed. Such exercises may be confined to individual compounds.
