ORDER

Whereas an emergent situation has arisen in the district due to the outbreak of the threat of COVID-19, detection of COVID-19 positive in nearby Lohit district;

Whereas contact tracing has been initiated in nearby districts of Arunachal Pradesh and Assam;

Whereas a joint appeal has also been received from CBOs of the district (ABK and IMCLS) and other organisations for strict enforcement of lock down in the district;


Whereas it has been observed that the concerned public have not been following the order issued for scheduled opening of shops for respective villages/colonies and have also not been maintaining social distancing in the market areas;

I, Mitali Namchoom, IAS DC cum DM hereby direct that opening of all shops and business establishments which includes grocery shops, vegetable markets and meat/fish vendors are hereby temporarily suspended w.e.f. 04/04/2020 in the entire jurisdiction of Lower Dibang Valley district till the end of lockdown period or until further orders, and restrict all movement of vehicles and individuals in the market area/colonies/villages. An arrangement for ensuring supply of essential commodities shall be made effective w.e.f. 6th April 2020 for delivery of essential commodities to individual households in the district. This shall also include MS/HSD retail outlets who shall issue petrol and diesel only to individuals/vehicles who have been issued passes only on emergent medical cases, as per application routed to the undersigned through the DFCSO.

The ban of movement of vehicle and people shall also apply on all institutions/organisations who have labourers staying at different sites including BRO, NHPC, NHIDCL and other departmental contractors due to lockdown. Any requirement of essential commodities by the departments (BRO/NHPC/NHIDCL/Depts) shall be procured through an application routed through the Supdt (Tax & Excise), two days in advance, along with details of items and address of the supplier to be procured from. Procurement pass and vehicle movement pass shall be issued only to such applications. The details of suppliers will be issued along with the order notifying details of home delivery.

Only vehicles engaged in COVID-19 duty or passes issued by the office of the undersigned shall be allowed to move. Exemptions are made to movement of people to medical/pharmacy. Any individuals found violating this order shall be booked under appropriate sections of Law.

The Addl. Deputy Commissioner, Dambuk and Sub- Divisional Officer, Hunli shall ensure implementation of this order at their administrative jurisdiction.


