ORDER FOR CONTAINMENT ZONE

Whereas SoP issued by the Govt of Arunachal Pradesh dated 18th July 2020 mandates Rapid Antigen test of all returnees to the state;

Whereas Rapid Antigen Test taken on 21ST July 2020 at Shantipur checkgate returned one positive result for an individual moving from Tinsukia/Sadiya to Lower Dibang Valley on 21ST July 2020;

Whereas contact tracing initiated has revealed that he is a driver and has been a resident of Cheta-II village, Roing circle;

Whereas as per protocol, he has been shifted to Covid Care Center, Lower Dibang Valley, as per SoP and RTPCR test is to be taken in order to establish the result;


Whereas it has become expedient to break the chain and contain the spread of any possible infection from individuals who have come into contact with the COVID-19 positive person and there is possibility of spread of COVID-19 if not contained;

Therefore, as authorized by the MHA order No.40-3/2020—DM-I(A) dated 29th June 2020, I, Mitali Namchoom, District Magistrate cum Chairperson, District Disaster Management Authority (DDMA), in the interest of public health, do hereby declare the following area as CONTAINMENT ZONE within the boundaries so declared with immediate effect and in conformity with the provisions of Sec 30 and 34 of Disaster Management Act 2005, do hereby order the following restrictions/regulations :-

1. CONTAINMENT ZONE: PLOT OF LAND AND BUILDINGS OF SHRI. MEHERA MIHU AND ADJACENT PLOT OF SHRI. JONGO MIHU.
2. BOUNDARY OF CONTAINMENT ZONE
 - a. North: BOUNDARY BETWEEN SMT ADIGE MENJO AND SHRI. HOSA KECHE and plot of SHRI. MEHERA MIHU AND SHRI. JONGO MIHU.
 - b. East : ROAD LEADING TO CHETA SCHOOL
 - c. West : ROAD LEADING TO NANI MARIA SCHOOL
 - d. South : ROAD LEADING TO RAYANG
3. The buffer zone for the containment shall be so declared upon the findings of contact tracing initiated by DMO Roing and recommendations if any.
4. The Security deployed is to ensure that the residents of the area shall not move out of the area for a period of 28 days from the detection of the case or until further orders or as approved by DC and DMO Lower Dibang Valley on medical exigencies;

5. The Security deployed is to ensure that no unauthorized persons shall be allowed to enter or exit the area without prior approval of the DC/DMO/DSO;
6. The area shall be barricaded and cordoned off and entry/exit shall be regulated by the security deployed;
7. All essential items required shall be home delivered by a team comprising officials of Tax and Excise Dept (Shri. Kanggong Dai, Supdt (T-E)-9862555720 and DFCSO (R. Ratan-9862744307, Hage That :-8794590093). The orders shall be received between 0800 hrs to 1100 hrs of a particular day and delivery undertaken between 1400 HRS to 1600hr on payment basis.
8. The DMO Lower Dibang Valley shall deploy a medical team to attend to any medical needs of the residents of the area;
9. The DMO shall constitute a RRT to continue with contact tracing of any individual found positive;
10. The DMO/DSO shall carry out antigen/RT-PCR/True Nat testing of residents as decided by RRT so constituted and also recommend the duration and extension of quarantine and other follow up action to be taken to contain any spread of infection;
11. No gathering shall be allowed within the containment zone;
12. The perimeter of the containment zone shall be the area as mentioned above at. The perimeter is subject to change as per subsequent findings.

The order shall remain in force and until further orders. Any violation shall be prosecuted under Sec 51 of Disaster Management Act 2005 and under Sec 188 of CrPC.





8. The DMO Roing for information and necessary action. An action taken report may be submitted by 1700 hrs of 22-07-2020.
 9. The DSO (IDSP) for information and necessary action;
 10. All Admin Officers for information and necessary action. Magistrates on daily rooster shall make mandatory rounds of the area
 11. Shri. Rakesh Tacho, EAC cum Incident Commander, Cheta area for information and direction to monitor the execution of the order, in coordination with the Nodal Officer, Cheta;
 12. Smt. Olak Apang, EAC cum Nodal Officer (health) for information and direction to liaise with the DMO/DSO to extend or restrict the containment zone and buffer zone as per contact tracing on a daily basis.
 13. The DDMO, Roing to provide all support as required including posters/banners/ribbons etc to barricade the area.
 14. The Supdt (Tax & Excise) and DFCSO Roing for information. Supdt (T&E) shall be the nodal officer for the purpose.
 15. All HODs, Lower Dibang Valley District for information and necessary action.
 16. The DIPRO, Lower Dibang Valley District for wide publicity.
 17. The DIO (NIC) for updation in the Official website.
 18. The Officer-in-Charge, Police Station, Roing for information and necessary action.
 19. The GB, Cheta-1 and 2 for information and necessary action.
 20. The President/Secretary ABK/IMCLS/NGOs/CBOs.
