ORDER

In pursuance of the revised SoP issued by the Govt of Arunachal Pradesh, dated 2nd Aug 2020, and in view of the increasing cases of COVID-19 in the state, the following regulations are hereby issued for strict adherence by all returnees to Lower Dibang Valley:

1. GENERAL :

- a. **ALL RETURNEES TO THE DISTRICT SHALL BE ROUTED ONLY THROUGH SHANTIPUR CHECK GATE;**
- b. **All returnees desiring to return to Lower Dibang Valley through Ruksin Check gate are informed to divert themselves to Shantipur Checkgate via Dibrugarh/Tinsukia**
- c. **All returnees with smartphones must install AAROGYA SETU app In their mobiles.**
- d. **The order shall not be effective for passes issued or for applications received till 3rd of Aug 2020 In the office.**
- e. **All pass for entry shall be issued only upon application being made to DC Roing (can be emailed at spatodcroing@gmail.com or sent via whatsapp at 7628020415) five days in advance during working hours and working days;**

2. MOVEMENT OF PEOPLE (INTER -STATE) and ICR returnees

- a. **All returnees from outside of Arunachal Pradesh shall be routed only through Shantipur check-gate;**
- b. **In view of the condition prevailing at ICR for the last three weeks and the need to cross Assam, all returnees from ICR shall be considered as inter-state returnee till 20th Aug 2020;**
- c. **They shall apply 5 days in advance with documents (ILP/Govt Id for NON APST, and any photo ID for APST) in format appended as Annexure A. All returnees desiring home quarantine shall also submit details of facility available for home quarantine (address, guardian, phone number with separate toilet and rooms) to be verified.**
- d. **The permission for home quarantine shall be subject to inspection of the facility by the nodal officer appointed for the purpose and home quarantine allowed only upon action by the inspecting officers as per govt direction ie availability of**
 - i. **Separate toilet;**

- ii. Separate well ventilated room.
- iii. Undertaking to the effect that he/she shall maintain protocol.
- e. Anybody desiring to return without such facilities (sharing rented accommodation with combined facilities) or having reported to the border check post at Shantipur without completing the due formalities shall be denied entry or invariably be sent to paid quarantine if entry is allowed as per exigency.
- f. All returnees must undergo mandatory test as per revised SoP;
- g. Irrespective of the status of ILP being held by the returnees from other states, all returnees shall apply for fresh permit from the Deputy Commissioner (LDV) and shall be allowed to enter the district only on production of pass issued by the Deputy Commissioner (LDV);
- h. Any person from Lower Dibang Valley desiring to travel to ICR for medical reasons shall be issued **ONLY ONE TIME EXIT PASS**, with proper referral from DMO Roing and return as per SOP provided at Sl 1(a) to Sl.(g).
- i. Any official or staff desiring to travel to ICR and return to the district are directed to apply through the concerned HoD, with details of leave/duty (also to include quarantine period) and as per application for returning to the district. Any staff or official putting up with families in the district and moving to ICR shall invariably be sent to paid quarantine or home quarantine subject to availability of facility as per SoP. HODs are not to entertain any movement of staff or officers to ICR without valid permission of the Deputy Commissioner.

3. MOVEMENT OF PEOPLE (INTER DISTRICT -except ICR)

- a. All inter-district movement between Anjaw/Lohit/Namsai and TCL districts towards western Arunachal and all movement from western Arunachal towards the eastern districts via Dambuk-Roing-Koronu route shall be allowed only between the period 0600 HRS to 1900 HRS, **except on medical emergencies**, which must be accompanied with valid referral from health authorities;
- b. They shall invariably report at the check-gate (Koronu/Dambuk) and collect transit pass from the check-gate and have it recorded during the exit from the district (Koronu/Dambuk).
- c. THEY SHALL NOT TAKE ANY DETOUR OR HALT AT ANY PLACE IN THE DISTRICT DURING THE JOURNEY.**

Action: SP Roing, ADC Dambuk and CO Koronu

d. RETURNEES FROM NAMSAI/EAST SIANG/CHANGLANG

- In view of the containment zones being declared in East Siang, Namsai and Changlang districts, all returnees from the above three districts shall be allowed into the district only with duly issued movement passes issued by respective DCs as well as DC Roing.
- This arrangement shall remain in place till 20th Aug 2020.

Action: SP Roing, ADC Dambuk and CO Koronu

e. All people having travelled to East Siang district in the last 15 days for medical reasons are directed to report to DMO Roing/DSO Roing for medical counselling/check up and rapid antigen test if required.

4. CONTRACTORS/PROJECT AGENCIES/ARMY-PARAMILITARY FORCES (ITBP/INDIAN ARMY/BRO)/TRUCK DRIVERS/LABOURERS etc

- a. The SOP devised and issued by DC Roing vide order dated 20TH July 2020 as per SOP devised by the govt dated 18th July 2020 shall remain in force until further order for all categories of people under S.4.

Anybody found violating the order shall be liable to be booked under relevant provisions of Sec 51 to 60 of the Disaster Management Act 2005, besides legal provisions under Sec 188 of IPC.


