ORDER FOR CONTAINMENT ZONE—OLD POST OFFICE COLONY : ROING

Whereas one person who had reported to district hospital and six of his primary contacts (family members) have tested positive as per RAT test for COVID-19 on 9th Sept 2020

Whereas it has become expedient to break the chain and contain the spread of any possible infection from individuals who have come into contact with the COVID-19 positive person and there is possibility of spread of COVID-19 if not contained;

Whereas the DSO (IDSP), Roing has recommended declaration of containment zone in the area;

Therefore, as authorized by the MHA order No.40-3/2020—DM-I(A) dated 29th August 2020, I, Mitali Namchoom, District Magistrate cum Chairperson, District Disaster Management Authority (DDMA), Lower Dibang Valley in the interest of public health, do hereby declare the following area as CONTAINMENT ZONE within the boundaries so declared with immediate effect and in conformity with the provisions of Sec 30 and 34 of Disaster Management Act 2005, do hereby order the following restrictions/regulations

1. **CONTAINMENT ZONE: old post office colony (quarters on adjacent side of the road leading to GHSS teachers colony).**
2. No individual shall enter or exit the zone for the period till contact tracing is conducted and RT PCR/Antigen test/True Nat test conducted and declared free of infection;
3. The buffer zone for the containment shall be so declared upon the findings of contact tracing initiated by DMO Roing and recommendations if any.
4. The area shall be barricaded and cordoned off and entry/exit shall be regulated by the security deployed;
5. The police deployed is to ensure that no unauthorized persons shall be allowed to enter or exit the area without prior approval of the DC/DMO/DSO;
6. All essential items required shall be home delivered by a team comprising officials of Tax and Excise Dept (Shri. Kanggong Dai, Supdt (T-E)-9862555720 and DFCSO (R. Ratan-9862744307, Hage Tath:-8794590093).
7. The DMO shall constitute a RRT to continue with contact tracing of any individual found positive;
8. The DMO/DSO shall carry out antigen/RT-PCR/True Nat testing of residents as decided by RRT so constituted and also recommend the duration and extension of quarantine and other follow up action to be taken to contain any spread of infection;
9. No gathering shall be allowed within the containment zone;
10. The perimeter of the containment zone shall be the area as mentioned above at. The perimeter is subject to change as per subsequent findings.

The order shall remain in force for a period of 14 days w.e.f 9th Sept 2020. Any violation shall be prosecuted under Sec 51 of Disaster Management Act 2005 and under Sec 188 of IPC.
