ORDER FOR CONTAINMENT ZONE-6- STAFF COLONY OPPOSIT ANAKUM SCHOOL, ROING AND SHANTI MARKET; ROING.

WHEREAS, 07 (Seven) numbers of primary contacts of positive case of staff colony opposite anakum school, Roing and shanti market Roing have tested positive as per RAT test for COVID-19 on 11th, 12th & 13th Sept/2020.

WHEREAS, it has become expedient to break the chain and contain the spread of any possible infection from individuals who have come into contact with the COVID-19 positive person and there is possibility of spread of COVID-19 if not contained.

WHEREAS, the DSO (IDSP), Roing has recommended declaration of containment zone in the area:

Therefore, as authorized by the MHA Order No.403/2020-DM-I(A) dtd. 29th August 2020, I Mitali Namchoom, District Magistrate-Cum-Chairperson, District Disaster Management Authority (DDMA), Lower Dibang Valley in the interest of public health, do herteby declare the following area as CONTAINMENT ZONE within the boundaries so declared with immediate effect and in conformity with the provisions of Sec. 30 and 34 of Disaster Management Act 2005, do hereby order the following restrictions/regulations.

- CONTAINMENT ZONE :- STAFF COLONY OPPOSIT ANAKUM SCHOOL, ROING AND SHANTI MARKET; ROING.
- No individual shall enter or exit the zone for the period till contact tracing is conducted and RT/PCR/Antigen test/True Nat test conducted and declared free of infection;
- 3. The buffter zone for the containment shall be so declared upon the findings of contact tracing initiated by DMO, Roing and recommendations, if any.
- 4. The area shall be barricaded and cordoned off and entry/exit shall be regualted by the security deployed;
- The Police deployed is to ensure that no unauthorized persons shall be allowed to enter or exit the area without prior approval of the DC/DMO/DSO;
- All essential items required shall be home delivered by a team comprising Officials of Tax & Excise Dept. (Shri Kanggong Dai, Supdt. (Tax Excise)- 9862555720 and DFCSO (R. Ratan-9862744307, Hage Tath- 8794590093.
- The DMO shall constitute a RRT to continue with contact tracing of any individual found
 positive and to make it mandatory for one Medical team to visit the colony every day;
- 8. The DMO/DSO shall carry out antigen/RT-PCR/True Nat testing of residents as decided by RRT so constituted and also recommend the duration and extension of quarantine and other follow up action to be taken to contain any spread of infection;
- 9. No gathering shall be allowed within the containment zone;
- 10. The perimeter of the containment zone shall be the area as mentioned above. The perimeter is subject to change as per subsequent findings.

The order shall remain in force for a period of 14 (fourteen) days w.e.f. 14th Sept/2020. Any violation shall be prosecuted under Sec. 51 of Disasster Management Act 2005 and under Sec. 188 of IPC.
