ORDER

WHEREAS, the District Border Students Union (DBSU) had submitted a representation to the District Administration, Lower Dibang Valley regarding encroachment of areas in Paglam circle by Assam;

Whereas a report was sought from SDO Paglam on the matter vide letter dtd 25th Aug 2020;

Whereas the report of SDO Paglam dtd 8th Sept 2020 was furnished to the Govt of Arunachal Pradesh and a meeting was held with DFO (T), Admin Officers and DBSU and the matter explained to DBSU on 22nd Sept 2020, including the fact that the area under contention was *sub judice* in the Hon'ble Supreme Court in the matter of Inter State Boundary issue between Arunachal Pradesh and Assam and hence the Govt had been apprised of the concerns by the District Administration.

Whereas a meeting was held on 12th Oct 2020 at Itanagar between the Chief Secretaries of Govt of Arunachal Pradesh and Govt of Assam, with DC Roing also as one of the attendees, wherein the concerns, issues and grievances of Paglam circle were also conveyed and the highlights of the meeting widely reported in the media.

Whereas the office of Deputy Commissioner, Lower Dibang Valley was in receipt of a letter from DBSU declaring its intent to call district bandh on 20th Oct 2020;

Whereas bandhs have been declared illegal by the Hon'ble Supreme Court in its various rulings, and

Whereas the district has been facing the COVID-19 pandemic like all other districts and states and the need of the hour is to ensure hassle free environment for all public and officials;

Whereas reports from social media and various organisations are indicative that such a bandh shall invite law and order problem in the district, besides affecting scheduled interviews and official programmes, and normal day to day life of common public;

And now therefore, I, Mitali Namchoom, District Magistrate cum Deputy Commissioner, Lower Dibang Valley declare the proposed bandh to be illegal and anybody proceeding ahead with the bandh to be prosecuted under relevant provisions of law in force.
