ORDER

Whereas an emergent situation has arisen in the district due to detection of positive cases of COVID-19 in the district and Govt of Arunachal Pradesh vide No. Secy (Health) Covid-19/11/2020/213 Dated Itanagar the 28th April 2021 has approved the imposition of lockdown in Lower Dibang Valley district for a period of 10 days.

I, **Kesang Ngurup Damo**, Deputy Commissioner cum District Magistrate, Lower Dibang Valley District, Roing do hereby declare **COMPLETE LOCK DOWN** for a period of 10 (ten) days in the district w.e.f. 0500 hrs of 29th April 2021 to 0500 hrs of 9th May 2021.

1. The suspension of following activities shall apply in the entire district.

1. Operation of all shops and business establishments including selling of meats/vegetables.
2. Operation of all vehicular movement in the entire district
3. Any kind of construction activities in sites operated by Govt and Private individuals.
4. Public movement and operation of all works in offices and institutions.

2. The following exemptions shall apply

1. Movement of people for vaccination to Vaccination centers, provided registration in CoWin portal is shown to the police on duty, including age proof and following Covid Protocols;
2. Evacuation of patients
3. Movement of essential items through permission issued by office of undersigned.
4. Medical services, fire, electricity, water, milk van, sanitation services, Pharmacies/ BSNL and Internet Service providers.
5. Movement of Defence/Paramilitary forces to border areas
6. Movement of officials on Covid duty (Ex. Magistrates, Police, Medical)

3. Delivery of food and essential services in Roing township

1. Delivery of food and essential services in Roing township shall be activated by Supdt (Tax & Excise) w.e.f. 1st May 2021 and a separate order shall be issued


4. Delivery of food and essential services in other sub divisions

1. The Addl. Deputy Commissioner, Dambuk, Sub- Divisional Officer, Hunli/ SDP Parbuk/SDO Paglam and CO Koronu shall make separate arrangements. They shall also ensure implementation of the order in their administrative jurisdiction.

5. Movement of inter-state and inter district people

1. Inter district movement through Lower Dibang Valley as transit shall not be allowed and are to be routed through Dibrugarh (Assam)
2. Exit pass from the district.

3. **One time exit pass out of the district** shall be issued on application made two days in advance to the control room (9863064149-whatsapp)/ dc-ldvalley-arn@nic.in (email) and the pass shall be issued in online mode.
