
ORDER

In view of the alarming situation arising due to COVID-19 Pandemic in the district , an urgent meeting with District Police , Administrative Officers , District Medical Officer , District Disaster Secretary Chairperson of Bazaar Committee Roing was convened on 26th April/2021 at 10-30 hours at DC's Conference , Hall Roing and after thread bare discussion , the following resolution / directives have been adopted for strict adherence by every citizen in letter and spirit to contain the virus .

1. Gatherings in Religious places / Social gatherings /Gymnasium /Recreational Facilities /Games and Sports are hereby temporarily suspended with immediate effect .
2. The operation and uniform timings of all Shops / Commercial establishment in the District will be **from 6 am to 6 pm** with immediate effect.
3. All HODs / Users Agencies / Construction Companies to designate their Officers as Nodal Officer for proper monitoring of their staffs under home isolation . Names of departmental Nodal Officer for respective circles to be submitted by 28/4/2021.
4. The President / Secretary Bazaar Committee is to designate reliable persons for monitoring person (s) under home isolation of their business community. Names of Nodal Officer to be submitted by 28/4/2021.
5. The Administrative Officers in consultation with PRI members , HGBs/GBs /Banggo Secretaries of concerned village shall take similar action for monitoring person(s) under home isolation. They are to liaise with M.O. In-charge , Anganwadi workers and Ashas in respective areas.

All the citizens of Lower Dibang Valley District are hereby directed to maintain protocol of social distancing , wearing mask and using soaps/sanitizers in their daily routine and report themselves to the Medical Officer , District Hospital ,Roing / District Surveillance Officer (IDSP),Roing or the Nodal Officer of the area , in case of development of any symptoms.

In case of any violation of this Order , defaulters shall be prosecuted under Sec. 51 of National Disaster Management Act 2005 and under Sec. 188 of IPC.
