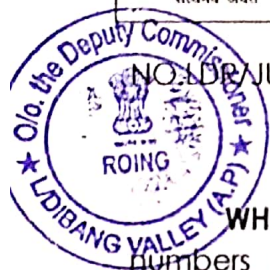

ORDER FOR MICRO CONTAINMENT ZONE.

WHEREAS, 10 (Ten) numbers of COVID-19 cases from Cheta-I village and 09 (Nine) numbers from Cheta-II village have been detected during Rapid Antigen Test (RAT) conducted from 25th June/2021 to 5th July/2021.

WHEREAS, it has become expedient to break the chain and contain the spread of any possible infection from individuals who have come into contact with the COVID-19 positive person and there is every possibility of spread of COVID-19 if not contained.

WHEREAS, recommendation has been received for declaration of **Micro Containment Zone** in the area vide letter No. LDVM/COVID-19/21-22/182 dtd. 5th July/2021.

Therefore, as authorized by the MHA Order No.403/2020-DM-I(A) Dtd. 23rd March/2021 and in pursuance of the direction issued by the Chief Secretary-cum-Chairperson, State Executive Committee, Govt. Of Arunachal Pradesh, Itanagar vide No. SEOC / DRR&DM/ 01/2011-12 Dtd 07.05.2021.

I, Kesang Ngurup Damo, District Magistrate-Cum-Chairperson, District Disaster Management Authority (DDMA), Lower Dibang Valley in the interest of public health, do hereby declare the following area as **CONTAINMENT ZONE** within the boundaries so declared with immediate effect and in conformity with the provisions of **Sec. 30 and 34 of Disaster Management Act 2005**, do hereby order the following restrictions/regulations.

MICRO CONTAINMENT ZONE 'CHETA-I', ROAD PASSING THROUGH LEFE PULU RESIDENCE TO TRI-JUNCTION OF HETA MENA SHOP AND FOR 'CHETA-II', ROAD PASSING THROUGH NEGI LINGGI RESIDENCE TO CULVERT OF NANI MARIA SCHOOL.

1. No individual shall enter or exit the containment zone for the period till contact tracing is conducted and RT/PCR/Antigen test/True Nat test conducted and declared free of infection.
2. The Buffer Zone for the containment shall be so declared upon the findings of contact tracing initiated by DMO, Roing and recommendations, if any.
3. The area shall be barricaded and cordoned off and entry/exit shall be regulated by the Police deployed by Superintendent of Police, Lower Dibang Valley District, Roing.
4. The Police deployed are to ensure that no unauthorized persons shall be allowed to enter or exit the area without prior approval of the DC/DMO/DSO.
5. The DMO/ DSO & Med. Supdt. Roing shall carry out antigen/RT-PCR/True Nat testing of residents as decided by RRT so constituted and also recommend the duration and extension of quarantine and other follow up action to be taken to contain any spread of infection.
6. The Control Room of DMO and DSO, District Hospital Roing, shall conduct surveillance, monitor health status and medical counselling over mobile phone thrice in a week as to ensure that the person tested positive is properly maintaining the COVID SOPs during the period of Home Isolation within Containment Zone.

7. No gathering shall be allowed within the containment zone.
8. The perimeter of the containment zone shall be the area as mentioned above. The perimeter is subject to change as per subsequent findings.

The order shall remain in force for a period of 14 (Fourteen) days w.e.f. **06/07/2021 to 19/07/2021 and further order from the undersigned.**

Any violation shall be prosecuted under Sec. 51 of Disaster Management Act 2005 and under Sec. 188 of IPC.

The Superintendent of Police and District Medical Officer, Lower Dibang Valley District Roing are enjoined upon to enforce this order.
