NO.LDR/FCS/126(CIRCULAR)2015-16(PT-II)/983-95 In continuation of Order No.LDR/JUD-21/2019-20/255-315 Dtd. 3<sup>rd</sup> April'2020 and in order to avoid any starvation in the district, all the general public, bonafied ration card holders of GHH/PHH/AAY and Fair Price shop dealers of FPS Mayudia/Kebali/Chidu/Ezengo/D.V Lamp -I / II,Mayu/ Sema Alo,Mayu/ KeraAti/ Jorpa Linggi/Meka/Jampi Linggi,Middle Market/Jome Mele,Lower Market / Cheta-I & II/ Ashali-I&II/ Rayang /ITI Roing/ Meselo/ Balek/ Old Abali/ New Abali/Khinjili//Mebe Miso,Iduli/Dature Miuli Iduli(T.E)/Harupahar/Emuli/Rukmo under Roing Admin. Circle are hereby inform that all FPS shall remain open w.e.f. **11/8/2021** onwards till complete issuing of the Rice to entitled Ration Card Holder(s) against the month of **AUGUST'2021** so as to ensure 100% distribution to all Ration Cards Holders.

The Rice Distribution Day for Dambuk /Paglam /Hunli /Desali /Parbuk/ Koronu Admin.Circle(s) shall be fixed as per their Administrative Convenient with intimation to this office.

**NOTE:-** (1) In case of any technical failure arising out of the e-POS Machine on processing of issue of Rice, it is instructed that on such technical problem, the TPDS ration items should be issued as usual of manual process and under any circumstances, non of the R/Card holder(s) should be deprived from availing his/her entitled quota.

(2) As per Govt. Vide order No.DFCS/EZECOMP/FPS(RFP)/2018 (Pt-1) dated 22/1/2021, the revised selling rate per kg for GHH rice is Rs, 13.50 for soft areas & Rs, 15/- for Hard areas i.e. Hunli / Desali /Paglam & Dambuk Circle.

(3) As per latest Govt. Vide NO.DFCS/NFSA/ALLN/2021 DATED 30/3/2021, the prescribed scale for GHH Rice has been revised at the rate of 4.865 kgs instead of 5(five) kgs per unit per person, and there is no changes for PHH & AAY Rice.

(4) The Revised Selling Rate of Rs, 13.50 (for Soft belt) & Rs, 15/-(for Hard belt) per kg against GHH Rice is inclusive of Rs, 2/- per kg which is to be deposited by the respective FPS dealer(s) into the PFMS Account of DF&CS Naharlagun through District PDS Nominee and DF&CSO Roing. So, all FPS to ensured for its deposition as sensitized in the coordination meeting held on 29/6/2021.

(5)All FPS should ensured to issue Free Rice under PMGKAY-IV scheme @ rate of 5 kg per per unit to the PHH & AAY Ration card holder(s) in adition to the regular monthly allotted quantity for the month of August & September'2021 on receiving of the two months from the Carriage Contractor.

(6)ALL FPS Dealer(s) OR Ration Card Holder(s) should ensured for maintaining of SOP while issuing and drawing of TPDS Rice under NFSA Viz; wearing of musks, sanitizing of own hand, social distancing etc.
