ORDER NO - 872

The President, Shop keepers Association, Car Nicobar vide his letter dt. 26th Mar. 2020 has requested to grant permission in favour of M/s. Islander Store, Perka, Car Nicobar; M/s. S.K. Enterprises, Perka, Car Nicobar; M/s. AMS General Store, Big Lapathy, Car Nicobar; M/s ABZ General Store, Sawai, Car Nicobar for door to door delivery of essential Commodities.

As a mark of precaution in the wake of the threat from the Novel Coronavirus Disease (COVID-19), under the aegis of the Andaman and Nicobar Administration, the District Administration is taking initiative to distribute essential to each and every household at their doorstep under its jurisdiction. The groceries, sanitary items and essential items of minimum requirement basis shall be delivered on payment to the households directly by the shopkeepers specifically identified for this purpose. The household requirement shall be conveyed to their respective **Headmen** who in turn will communicate the same to the shopkeepers and the package containing groceries, sanitary items and essential items will be delivered at home within 24 hrs. The above service will be started from 26th Mar. 2020.

The entire process will be completed via SMS/Whatsapp and phone calls. This is planned to restrict the public movement and the retailers advised to strictly follow the Andaman and Nicobar Administration directives in letter and spirit.

The Andaman and Nicobar Administration endeavour is to make delivery of the essential commodities at the doorsteps of each household, through this mechanism. **Shopkeepers are advised to keep at least one meter distance while supplying the items, use face mask, hand gloves and in case if hand gloves not available then sanitize their hand by using the sanitizer/soap before and after delivery of the essential commodities**
