OFFICE ORDER No. 02

As a mark of precaution in the wake of threat from Novel Corona Virus Disease (COVID-19) under the aegis of the Andaman & Nicobar Administration, the District Administration is taking initiative to distribute essential to each and every household at their door step under its jurisdiction. The Groceries, sanitary items and essential items of minimum requirement basis shall be delivered on payment to the household directly by the shopkeepers specially identified for this purpose. The house hold requirement shall be convey to their respective Headman who in turn will communicate the same to the shopkeepers and the package containing Groceries, sanitary items and essential items will be delivered at home 24hrs. The above service will be started from today onwards.

The entire process will be completed via SMS/Watsapp and phone calls. This is planned to restrict the public movement and the retailers advised to strictly follow the Andaman & Nicobar Administration directives in letter and spirits.

The Andaman & Nicobar Administration Endeavour is to make delivery of the essential commodities at the door steps of each household, through this mechanism. **Shopkeepers are advised to keep at least one meter distance while supplying the items, use face mask, hand gloves and in case if hand gloves not available then sanitized their hand by using the sanitizer/soap before and after delivery of essential commodities.**
