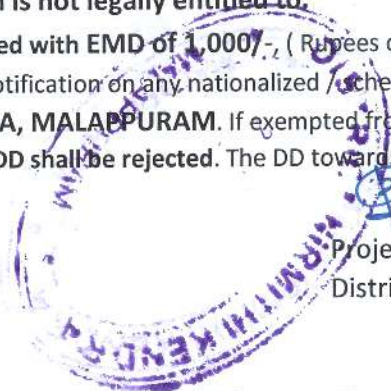

- 3 Payment shall be released within 15 days from date of receipt of bills
- 4 The Supplied items should be of original make only.
- 5 Goods may be delivered at site within 7 days from the date of issue of Supply Order.
- 6 The Liquidated damage charges if the supplier fails to deliver the goods and/or perform the services within the contractual delivery period for reason other than circumstances beyond supplier's control (which will be informed by the supplier I writing and agreed to by) and the purchaser extends the delivery period, the purchaser will also deduct from the contract price, as liquidated damages, a sum equivalent to 0.5% (half per cent) of the delivered price of the delayed goods or unperformed services for each week of delay or art thereof until actual delivery of performance.
