WHEREAS, there has been spike in Positive Corona Cases from returnees who are coming from different States having lockdown and exponential cases; and

WHEREAS, due to highly contagious nature of virus, it is necessary to break the transmission chain and necessary to put in place preventive measures so that the pandemic of COVID-19 does not spread.

NOW, THEREFORE, I Shri. Garod L.S.N. Dykes, IAS, District Magistrate, West Jaintia Hills District, Jowai in exercise of the powers conferred upon me under section 144 Cr. P.C. read together with Regulation 3 of the Meghalaya Epidemic Diseases, COVID-19 Regulations 2020 **do hereby order:**

All Nursery, Lower Primary and Upper Primary Schools within Jowai Town shall remain closed with effect from 28th April, 2021 until further orders. However, ongoing MBOSE Examinations will continue as scheduled by strictly following COVID protocols.

Violation is an offence punishable with fine under Section 51(b) of the Disaster Management Act, 2005



In view of the urgency of the matter, this Order has been made ex-parte.
