**PROHIBITORY ORDER U/S 144 Cr.PC, 1973**

In continuation to the prohibitory order issued vide Order No. 3219/DC(S) dated: 04/04/2020 by the undersigned u/s 144(1) of the Code of Criminal Procedure, 1973, I, Ragul K, IAS, District Magistrate, South hereby direct the following:

1. The Prohibitory Order u/s 144 CrPC, 1973 issued vide Order No. 3219/DC(S) dated: 04/04/2020 regarding inter-state and intra-state movement of vehicles and opening of shops in the South Sikkim District shall **remain in force till 20<sup>th</sup> of April, 2020 or till further orders.**
2. As per the Office Memorandum bearing No.592/CS/SKM dated: 14/04/2020 all the passes and permits issued by the Additional District Magistrates, Sub-Divisional Magistrates, Block Development Officers, Head of Departments and other Departmental authorities other than Sikkim Police, Health & Family Welfare Department and Forest & Environment Department, shall **cease to be valid with effect from 05:00 P.M of 14<sup>th</sup> of April 2020.**
3. The vehicle passes shall be issued only by the concerned Additional District Magistrates, Sub-Divisional Magistrates, Block Development Officers and through E-pass at [www.covid19sikkim.org](http://www.covid19sikkim.org).
4. The police personnel on duty shall verify the validity of vehicle passes and check the supporting documents and ensure free movement of vehicles bearing valid passes.
5. The following automobile/tyre repair shops in the district shall be allowed to function from 9:00 A.M to 4:00 P.M, with bare minimum staff.

This Order shall come into force **with immediate effect** in the entire area of South Sikkim district and **shall remain in force till 20<sup>th</sup> of April, 2020 or till further orders.**
