**PROHIBITORY ORDER U/S 144 Cr.PC, 1973**

In supersession to order issued by the undersigned vide order no. 3367/DCS dated 3/5/2020 u/s 144(1) of the Code of Criminal Procedure, 1973 and in view of the Order No. 09/Home/2020 dated 17/5/2020 issued by the Chief Secretary, Government of Sikkim, I, Ragul K, IAS, District Magistrate, South hereby direct the following:

**1. Complete Safety Restrictions:**

- a. The new guidelines issued by the Chief Secretary, Government of Sikkim vide Order No. 09/Home/2020 dated 17/05/2020 shall be strictly complied by all residents of the district.

**2. Restrictions on Intra-state movement:**

- a. Any assembly of five or more persons shall be prohibited in the **entire area of South Sikkim district**. People are required to stay at home and come out for basic services while strictly following social distancing guidelines issued earlier.
- b. **Movement of persons/vehicles within the state shall be governed as per the provisions of Order No. 09/Home/2020 dated 17/05/2020 issued by the Chief Secretary, Government of Sikkim.**

**3. Restriction on Inter-state movement:**


- a. There shall be complete restrictions on interstate movement of light transport vehicles from outside the state. Essential commodities shall be transported only by trucks.
- b. Inter-state movement of persons/vehicles shall be governed as per the provisions of Order No. 09/Home/2020 dated 17/05/2020 issued by the Chief Secretary, Government of Sikkim except vehicles engaged in the transportation of foodgrains by Food Corporation of India, petroleum products, LPG cylinders, cash vans for ATMs, pharmaceuticals and other companies, SNT buses, ambulances, vehicles engaged in medical emergencies and law enforcement agencies i.e Police, Army, Paramilitary Forces, etc. which shall be exempt from the provisions of odd-even rules.

**4. Quarantine Instructions:**

- a. **All returnees from outside the state and other such persons** so required by Health Department authorities are directed to remain under strict home quarantine or facility quarantine for a period as decided by local Health authorities. Any person refusing to cooperate with the directions of the Health authorities shall be prosecuted u/s 188 and 270 of Indian Penal Code, 1860 in addition to the breach of this order.

This order shall come into force with effect from 18<sup>th</sup> May, 2020 in the entire area of South Sikkim district and shall remain in force till 31<sup>st</sup> May, 2020 or till further orders.
