

2. If any of these primary contacts develop symptoms during this period of quarantine they shall be tested and treated as per the health protocol.
3. All primary contacts shall stay in **home quarantine for a period of 11 days.**

If any person fails to comply with the directions of the Incident Commander he/she shall be held responsible and action u/s 188 of Indian Penal Code, 1860, and this order shall be initiated against them.

This order shall come into force with **immediate effect** in the **above specified area** and shall remain valid till further orders.


