

DETAIL TENDER CALL NOTICE

The Executive Officer on behalf of Bhawanipatna Municipality invites item **rate** bids in single cover system for supply, installation and commissioning of Modular Toilets as per the specification given in **Annexure-I** from the intending registered Firms /Manufacturers/ Authorized license supplier Dealers/ Distributors.

1. **BID Schedule and Address:**

2. **Cost of Tender Paper (Non-Refundable):** The cost of bid documents has to be paid by each bidder in shape of Demand Draft/Bankers Cheque drawn in favour of **Executive Officer, Bhawanipatna Municipality, Bhawanipatna** from any Nationalized / Scheduled Bank (mentioned in the above table) payable at **Bhawanipatna** separately for **Rs.10,000/-** preferably towards cost of tender paper and Tax (GST as applicable) .The quotation without paper cost shall be rejected out rightly.
3. **Deposit of EMD:** Bids must be accompanied by Earnest Money Deposit/ Bid security for an amount of **Rs.1,00,000/-** (Rupees One Lakhs) for the works, pledged in favour of **Executive Officer, Bhawanipatna Municipality, Bhawanipatna** will have to be in any one of the forms as specified in the bidding document. The tender without EMD shall be rejected out rightly.
4. After the date and time of receipt of bid is over, the original bid security (EMD) and demand draft towards cost of bid documents (Tender Paper cost) shall be submitted in the office of the undersigned on or before the date and time of opening of bid as specified in above table during office hours from to **Dt.05.09.2018 to Dt.07.09.2018** up to 01.00 AM through registered post/Speed post to Executive Officer, **Bhawanipatna Municipality, Bhawanipatna -766001**, falling which the bid shall be rejected. The authority will not be held responsible for any postal delay and non receipt of the same in time.
5. **Scope of work:**

5.1 Installation and commissioning of Modular Toilets in Bhawanipatna Municipal Council area, Bhawanipatna.

5.2 Specifications of the **Modular Toilets** are mentioned in the document vide **Annexure-I**.

5.3 The cost of delivery is in the scope of the bidder. No separate payment shall be made in this regard. Also in case of any breakage during delivery, then the bidder shall ensure that the toilet fixture is replaced at the bidder's cost.

6. **Due Diligence:**

6.1 The Bidders are expected to examine all instructions, terms and specifications stated in this DTCN.

6.2 The Bid shall be deemed to have been submitted after careful study and examination of this DTCN. Failure to furnish all information or submission of a bid not responsive to this Tender will be at the Bidders' risk and may result in rejection of the bid. **Bhawanipatna Municipality** is not bound to disclose the grounds for rejection of Bid. The decision of the **Bhawanipatna Municipality** regarding the final declaration of the successful Bidder shall be final.

7. **Eligibility Criteria:** The invitation to bid is open to all Bidders who qualify the Eligibility Criteria as given below. Failure to provide the desired information and documents may lead to disqualification of the Bidder for the next round.
- 7.1 The Bidder should either be registered Firms /Manufacturers/ Authorized license supplier Dealers/ Distributors of modular toilets (The bidder should provide all necessary supporting documents to substantiate the above respective claims.)
 - 7.2 The Bidder should not be currently blacklisted by any Government / Government agency/ Bank / institution in India or abroad. The bidder should provide declaration to this effect on their company's letterhead
 - 7.3 The Bidder should provide reference of 2 (two) clients who have procured modular toilets from them during last two financial or calendar years. (The bidder should provide all necessary supporting documents to substantiate the above respective claims.)

INSTRUCTION TO INTENDING BIDDERS

PARTICIPATING IN THE BID IN THE E-PROCUREMENT PORTAL: The Bidder intending to participate in the bid is required to register in the Portal with some information about the firm/Manufacturers/ Authorized license supplier Dealers/ Distributors. This is a onetime activity for registering in Portal. During registration, the Bidder has to attach a Digital Signature Certificate (DSC) to his / her unique user ID. The DSC used must be of appropriate class (Class II or Class III) issued from a registered Certifying Authority such as n-Code, Sify, TCS, MTNL etc.

- 1.1. Contractor exempted from payment of EMD will be able to participate in the tender directly by uploading documentary evidences towards his eligibility for such exemption.
- 1.2. The bidder intending to participate in the bid on-line shall prepare the demand draft towards cost of bid and up load the scanned copy of the draft to the portal against the bid where he is participating and the original shall be deposited to the tender inviting officer within the **period** specified in the "Invitation for Bid". If the Bidder fails to deposit the original demand draft towards cost of bid within the stipulated time his bid shall be rejected and action as per prevailing rule shall be taken
- 1.3. The bidder intending to participate in the bid on-line shall upload the scan copy of following documents

1.	PAN CARD
2.	GST REGISTRATION CERTIFICATE
3.	Firm Registration /Manufacturing license/ Authorized license for supplier Dealers/ Distributorship certificate /Dealership certificate.
4.	Required documents as per specification
5.	Letter of authorization for representing the manufacturer to sign the bid documents if any.
6.	Self-declaration about warranty period to be offer by the Manufacturing Company.
7.	All test certificate as per specification given.
8.	Under taking for replacement of defective materials.
9.	Copy of Guarantee certificate for a period of two years

- 1.4. The successful bidder shall give an undertaking to replace the defective materials within the guarantee period of two years.
- 1.5. The rate quoted should be valid for one year & supply order will be issued as per requirement in phase manner. Provided, if during the period of one year or during delivery of material, any reduction of price by the Company shall be applicable against supply order.
- 1.6. The contract period of the bid is meant for a period of one year.
- 1.7. The Bhawanipatna Municipality shall have the right to terminate the contract on the ground of improper performance and violation of the terms of the contract without assigning any reason by giving 15 days prior notice.
- 1.8. Any conditional and in completed bid is liable for rejection.
- 1.9. No claim shall be entertained towards any expense made by any bidder for submission of the bid in case of cancellation & rejection.
- 1.10. All bids received will remain ordinarily valid for a period of 120 days from the date of receipt of bids.

- 1.11. The bidders should quote rates inclusive of all taxes for each item both in figure and in words. Wherever there is a difference between the rate quoted in figures and words, the rate quoted in words will be taken as correct.
- 1.12. The successful bidder has to submit original challan copy of dispatch if supplied through their authorized stockiest and also furnish a certificate regarding their original product.
- 1.13. The successful bidder shall submit bill in triplicate along with guarantee certificate for trouble free and satisfactory service for a minimum period of one year in case of fitting.
- 1.14. The quantity mentioned in BOQ is the indicative figure to be purchased during a year. Supply order will be issued as per requirement in phase manner. The materials are to be delivered to Bhawanipatna Municipality store in single lot within 15 days from the date of issue of supply order.
- 1.15. Security @ 2% shall be deducted from every bill and the same shall be released after expire of guarantee period.
- 1.16. The Bhawanipatna Municipality shall deduct the statutory deduction as applicable under the income Tax Act 1961, Central Goods and Services Tax Act, 2017, Odisha Goods and Services Tax Act, 2017 and may other statutory deductions.
- 1.17. All the documents furnish by the bidder are subject to verification from the issuing authority in case any manipulation is found the EMD will be forfeited and steps shall be taken for black listing the bidder.
- 1.18. In case of any dispute in the meaning of specification, description of items, rates, condition of agreement or due to errors/ typo- graphical errors, omissions the decision of the bid accepting authority of Bhawanipatna Municipality with due recommendation of the engineer in charge of work is final and binding to the firm.
- 1.19. If the bidder fails to supply the materials as per order, then the differential cost with respect to the market value shall be recover from his bill keeping in view of exigency of the work duly approved in the Bhawanipatna Municipality.
- 1.20. In case of any dispute arising out of the contract, the matter shall be referred to the **EXECUTIVE OFFICER, BHAWANIPATNA MUNICIPALITY**, whose decision shall be final.
- 1.21. Consideration will be taken for the lowest bidder items wise quoted rate.
- 1.22. Modular Toilets and its accessories to be quoted as per the attached specification vide **Annexure –I**
- 1.23. Bhawanipatna Municipality has all the right to have the tests of the supplied materials if needed through an independent Agency at any moment of time and the cost must be borne by the Firm.
- 1.24. The technically qualified bidders shall be eligible for opening of financial bids.
- 1.25. The intending bidder shall quote their rates for Modular Toilet (Supply, Installation & Commissioning) including all taxes and statutory dues in financial bids.
- 1.26. The authority reserves all the rights to cancel the process at any time without assigning any reason thereof. Any dispute arising in this case shall come under the jurisdiction of courts of Bhawanipatna.
