O R D E R

By this order I, shall dispose of the mutation application of applicant Sh. Manvir Singh S/o late Sh. Shubh Ram, R/o H. No. 522, VPO Malik Pur, New Delhi, New Delhi who is seeking mutation on the basis of a Registered Will dated 15.06.2009 (Reg. No. 806 Book No. 3 Vol. No. 460) executed by Sh. Shubh Ram S/o Sh. Kanhaiya R/o VPO Malikpur, New Delhi for sanctioning mutation of 1/3 share in agricultural total land measuring 67 Bighas 1 Biswa in Khata/Khatoni no. 11/8, out of Khasra No. 9/20(4-16), 21(4-16), 12//1 (4-16), 26//14 min (3-12), 17 (4-16), 24/1(2-0), 24/2(1-0), 34//4(4-0), 7(4-16), 14(4-16), 17(4-16), 24(4-16), 40//3/2(2-6), 4(4-16), 7(4-16), 14(4-16), 59//3 Min (0-14), 6 Min (0-2), 16 Min (0-11) situated in the Revenue Estate of Village Malikpur, Tehsil Najafgarh in favour of his grandson Sh. Kapil S/o Sh. Manvir Singh and agriculture land area measuring 9 Bighas 12 Biswas in Khata/Khatoni no. 133/122 out of Khasra No. 15//17(4-16), 18(4-16) situated in the Revenue Estate of Village Malikpur, Tehsil Najafgarh in favour of his son Sh. Manvir Singh.

Reason of Dispute:-

In the Report dated 10.07.2018 of the Tehsildar (Najafgarh) it is stated that the deceased has distributed his land among his son (total 9-12 Bighas) and grandson (22-7 Bighas) in his will. The share he distributed is not equal.
