Scope of work: 175 KWp Grid Connected Solar Power Plant installed at Mini Sectt., Jhajjar & 100 KWp Grid Connected Solar Power Plant installed at Court Complex, Jhajjar. These CT/PT are to be installed for Net Metering arrangement at Mini Sectt., Jhajjar & Court Complex, Jhajjar.

Terms and Conditions

1. Only agency fulfilling the Government norms like Registration number, Service Tax No/GST No., PAN.
2. Income Tax return for last F.Y. year.
3. Turnover of firm/agency should be more than 01.00 crore.
4. Agency should have at least three years experience for supplying CT/PT.
5. If supplied CT/PT has not been passed by DISCOM then this is the responsibility of concerned supplier.
6. The Supplier will sole responsible for passing CT/PT from DISCOM.
