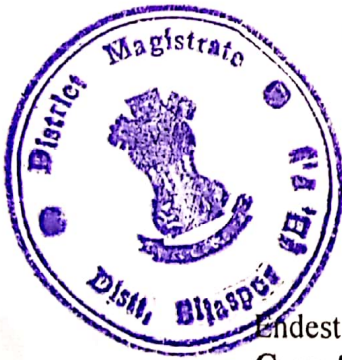

ORDER

In pursuance to Notification No. Home(A)A(9)-12/2020-L dated 30-06-2020 of the Additional Chief Secretary (Home) and letter No. Rev.(DMC)(C)20-2/2020-COVID-19 dated 30-06-2020 of the Principal Secretary (Rev.-DM) to the Govt. of Himachal Pradesh and in continuation of this office Order No. BLS-PESHI-1(1)/96-22725-875 dated 31st May, 2020, I, Rajeshwar Goel, IAS, District Magistrate, Bilaspur, District Bilaspur exercising the powers vested in me under Section 144 of Cr.PC, do hereby order that the prohibitory order issued by the undersigned U/S 144 of Cr. PC vide Order of even No. 22725-875 dated 31st May, 2020 and subsequent Orders shall continue to be in force in the entire territorial jurisdiction of District Bilaspur, Himachal Pradesh with the modification that movement of individuals shall remain strictly prohibited between 2100 HRS (09:00 PM) TO 0500 HRS (05:00 AM) EXCEPT FOR ESSENTIAL SERVICES AND ACTIVITIES.

This order shall come into force with effect from 01-07-2020 and shall remain in force till further orders. The violation of this Order shall attract provisions of Section 188, 269, 270, 271 of the Indian Penal Code, and all other relevant provisions of law and the violators shall be prosecuted accordingly.
