**ORDER U/S 144 Cr.P.C.**

**Whereas**, it has been brought to the notice of the undersigned by the Health Authorities of District Bilaspur that one positive case of COVID-19 has been found in **V.P.O. Brahmukhar, Tehsil Sadar, District Bilaspur**. Therefore, there is an imminent danger of spread of COVID-19 in the adjoining/ other parts of District Bilaspur and to take strict measures to stop the further spread of COVID-19, which if not taken immediately, can pose grave danger to the lives, health & safety of the residents of the area.

**Whereas**, it is the case of extreme emergency and the circumstances are such that serving of notice upon all persons residing in the jurisdiction of the area mentioned below is not practicable and possible and therefore, it is necessary and expedient to proceed under section 144 of the Code of Criminal Procedure, 1973.

**And Therefore**, in view of the above circumstances and as per the recommendations of Chief Medical Officer, Bilaspur as conveyed vide his office letter No. HFV-BLP(COVID)/Gen./2020-II-15860-72 dated 07-08-2020 and as a containment measure I, Rajeshwar Goel, IAS, District Magistrate, Bilaspur (Himachal Pradesh), in exercise of the powers vested in me under Section 144 of the Code of Criminal Procedure, 1973, do hereby **order and direct the COMPLETE SEALING OF THE AREA OF CONTAINMENT ZONE IN THE FOLLOWING MANNER:-**

It is further ordered that :-

1. UNDER NO CIRCUMSTANCES SHALL THERE BE ANY INGRESS/EGRESS OF ANY PERSON OR VEHICLE in the Containment zone except for persons/vehicles involved in enforcement of containment plan, medical emergency and **vehicles passing through NH-103 (without stopping / stepping out of the vehicle anywhere in the area falling under the above mentioned zones).**
2. The supplies of essential goods like milk, groceries, fruits, vegetables, medicines, cooking gas etc. in the above mentioned containment zone shall be made through the **Govt. Delivery Committee, headed and formed by the Sub-Divisional Magistrate concerned.**
3. No person in the containment zone shall leave their homes on foot or through vehicle or travel or move around, roam around or stand on any public path or place in the aforementioned area.

This order shall come in to effect immediately and shall remain in force till further orders.

Any violation of this order will attract provisions of Section 188 Indian Penal Code and the violator can also be prosecuted under section 269 and 270 of Indian Penal Code.
