ORDER

Whereas, one positive case of COVID-19 was detected in Village Panoul of Gram Panchayat Amarpur Tehsil Ghumarwin District Bilaspur H.P. and in order to contain the spread of COVID-19, the following areas of Sub-Division Ghumarwin, District Bilaspur were declared as Containment & Buffer Zones by Distt. Magistrate vide office his order No. BLS-PESHI-1(1)/96-36906-36926 dated 05th August, 2020:-

And whereas, in accordance to the recommendations of the Chief Medical Officer Bilaspur Distt. Bilaspur H.P. made vide his office letter No. HFW-BLP(COVID/Gen/2020-11-16829-32 dated 18-08-2020, all above mentioned areas have been recommended to be denotified as containment Zone. Now, in view of the recommendation of the Chief Medical Officer Bilaspur, District Bilaspur H.P. made vide his office letter referred to above, there is no need to continue the above mentioned areas of this Sub- Division Ghumarwin as containment area.

Therefore, I Shashi Pal Sharma, HAS, Sub- Divisional Magistrate, Ghumarwin District Bilaspur Himachal Pradesh in exercise of the powers vested in me under section 144(5) of the Cr. P.C. 1973, do hereby order that above mentioned areas of Sub- Division Ghumarwin, District Bilaspur, notified as containment / Buffer Zone by the District Magistrate, Bilaspur vide his office order of even No.36906-36926 dated 05-08-2020, shall no longer be sealed and is hereby denotified as Containment/Buffer Zone.

This order shall come in force w.e. f. Dated 18-08-2020.
