Samoh District Bilaspur H.P. and in order to contain the spread of COVID-19, the following areas of Sub-Division Ghumarwin, District Bilaspur were declared as Containment & Buffer Zones by Distt. Magistrate vide his order No. BLS-PESHI-1(1)/96-37702-37752 dated 08th August, 2020

And whereas, in accordance to the recommendations of the Block Medical Officer Jhandutta Distt. Bilaspur H.P. made vide his office letter No. HFW-BMO-JHD(COVID-19)/2020-3331 dated 20-08-2020, all above mentioned areas have been recommended to be denotified as containment Zone. Now, in view of the recommendation of the Block Medical Officer Ghumarwin, District Bilaspur H.P. made vide his office letter referred to above, there is no need to continue the above mentioned areas of this Sub- Division Ghumarwin as containment area.

Therefore, I Shashi Pal Sharma, HAS, Sub- Divisional Magistrate, Ghumarwin District Bilaspur Himachal Pradesh in exercise of the powers vested in me under section 144(5) of the Cr. P.C. 1973, do hereby order that above mentioned areas of Sub- Division Ghumarwin, District Bilaspur, notified as containment / Buffer Zone by by Distt. Magistrate Bilaspur order of even No. 37702-37752 dated 08th August, 2020, shall no longer be sealed and is hereby denotified as Containment/Buffer Zone.
