**ORDER**

Whereas, one positive case of COVID-19 was detected in Vill. Harlog, Gram Panchayat Harlog, Tehsil Ghumarwin, District Bilaspur H.P. and in order to contain the spread of COVID-19, the following areas of Sub-Division Ghumarwin, District Bilaspur were declared as Containment & Buffer Zones vide this office order No. GMR-PESHI-1(32)/97-IV-2107-16 dated 19<sup>th</sup> August, 2020:-

And whereas, in accordance to the recommendations of the Block Medical Officer Ghumarwin Distt. Bilaspur H.P. made vide his office letter No. HFW-BMO-GMR(COVID-19)/2020-V-9702 dated 01 09-2020, all above mentioned areas have been recommended to be de-notified as containment Zone. Now, in view of the recommendation of the Block Medical Officer Ghumarwin, District Bilaspur H.P. made vide his office letter referred to above, there is no need to continue the above mentioned areas of this Sub- Division Ghumarwin as containment area.

Therefore, I Shashi Pal Sharma, HAS, Sub-Divisional Magistrate, Ghumarwin District Bilaspur Himachal Pradesh in exercise of the powers vested in me under section 144(5) of the Cr. P.C. 1973, do hereby order that above mentioned areas of Sub- Division Ghumarwin, District Bilaspur, notified as containment / Buffer Zone by this office order of even No. 2107-16 dated 19<sup>th</sup> August, 2020, shall no longer be sealed and is hereby de-notified as Containment/Buffer Zone.

This order shall come in force w.e.f 00:01 A.M. on 02-09-2020.
