ORDER U/S 144 Cr.Pc.

Whereas, it has been brought to the notice of the undersigned, by the Block Medical Officer Markand/SNDJ District Bilaspur that many positive cases of COVID-19 has been found in Sub Division Shri Naina Devi Ji at Swarghat, District Bilaspur H.P. Therefore, there is an imminent danger of spread of COVID-19 in the adjoining/other parts of District Bilaspur and to take strict measures to stop the further spread of COVID-19, which if not taken immediately, can pose grave danger to the lives, health & safety of the residents of the area.

Whereas, it is the case of extreme emergency and the circumstances are such that serving of notice upon all persons residing in the jurisdiction of the area mentioned below is not practicable and possible and therefore, it is necessary and expedient to proceed under section 144 of the code of Criminal Procedure, 1973.

And therefore, in view of the above circumstances and as per the recommendation of Block Medical Officer Markand/SNDJ, District Bilaspur as conveyed vide his office letter No. HFW.BLS.Mkd.(PH)-37/20-III-9850-53 dated 06-05-2021 and as a containment measure I, Subhash Gautam (HAS) Sub Divisional Magistrate, Shri Naina Devi Ji at Swarghat, District Bilaspur Himachal Pradesh, in exercise of the power vested in me under Section 144 of the Code of Criminal Procedure, 1973, do hereby order and direct the **COMPLETE SEALING OF THE AREA OF CONTAINMENT ZONE IN THE FOLLOWING MANNER:-**

It is further ordered that:-

1. UNDER NO CIRCUMSTANCES SHALL THERE BE ANY INGRESS/ EGRESS OF ANY PERSON OR VEHICLE in the containment zone except for persons/vehicles involved in the enforcement of containment plan, medical emergency
2. The supplies of essential goods like milk, groceries, fruits, vegetables, medicine, cooking gas etc. in the above mentioned containment zone shall be made through the Govt. delivery **committee, headed by B.D.O. Shri Naina Devi Ji at Swarghat separately.**
3. No person in the containment zone shall leave their homes on foot or through vehicle or travel or move around, roam or stand on any public path or place in the aforementioned area.

This order shall come in to effect immediately and shall remain in force till further orders.


Any violation of this order will attract provisions of section 188 Indian Penal Code and the violator can also be prosecuted U/s 269 and 270 of Indian Penal Code.

Inspector FCS & CA will further identify shops for supply of essential items on approved rates. BMO Markand/SNDJ will ensure to put in place a system at Swarghat for catering to the medical emergencies. Drug Inspector Bilaspur will identify Medical store and ensure supply of medicines on door to door delivery basis. Concerned **Pradhan G.P.** will supply the essential items on door to door delivery basis. The committee will work under the overall supervision of Block Development Officer SNDJ at Swarghat.


In addition to this Officers of concerned departments at Sub Divisional/Block level will ensure execution of duties/roles as per order of District

Magistrate order No. HFW-BLP(IDSP)(COVID 19)Corr/2020-7866-77 dated 15-04-2020(copy enclosed).

The following precautions are to be ensured.


1. There should be no contact with the persons of the containment zone.
2. They will use mask/face cover all the time.
3. Requirement of non perishable items will be taken for at least 10 days.
4. No overcharging should be there.

The officers/officials so instructed for the purpose to note that any obstruction, resistance, negligence or refusal by any person or officer to comply with the directions aforesaid shall render such person or officer liable to prosecution under section 51, 55 and 56 of the Disaster Management Act 2005 in addition to violation of HP Epidemic disease (COVID-19) Regulations, 2020, Orders promulgated by District Magistrate under section 144 CrPC and will be dealt under relevant sections.
