In reference to the above, I am to inform you that the Election Commission of India, vide its letter no. 23/2020-ERS dt. 04.09.2020 has approved a change in the date of the draft publication of electoral rolls for the Special Summary Revision of Photo Electoral Rolls w.r.t. 01.01.2021 as the qualifying date, for the state, on account of the festival of "Bhatriidwitya" which is celebrated statewide. The Commission has also approved the Special Campaign dates to be held during the said period. The approved revised schedule is as follows:
