Tenderers have to abide by the following conditions :

- Tender will be in two bid system as per provision of rule 47C of the West Bengal Financial Rule Volume-I.
  - Technical bid** consisting of all technical details along with commercial terms and conditions. #
  - Financial bid** indicating rate as percentage below the estimated rate/ at per the estimated rate/Percentage % above the estimated rate ( as will be decided by the tenderer) at the specified place of **Tender Form** to be submitted with signature of the tenderer. The rate should be written both in word and figure and no overwriting is allowed. Any intending tenderer can purchase the Tender Form & Tender Documents at the prescribed rate as mentioned in the tender notice..

The technical bid and the financial bid should be sealed by the bidder in separate covers duly **super scribed and both the sealed covers** are to be put in a bigger cover which should also be **sealed and duly super scribed**. The technical bids shall be opened at the first instance and evaluated vis-à-vis terms and condition of tender. At the **second stage**, financial bids shall be opened for the technically qualified applicants only for furnishing value and ranking before finalization and awarding of the contract.

Both the technical & financial bids are to be opened in presence of the applicants who are likely to be present there.

Certificate / Last GST Return, Last Year (i.e. 2019-20 / 2020-21) Income Tax Return Certificate, Current P Tax Challan (i.e. from 01/04/2020 to 31/03/2021), Valid PAN Card & Credential Certificate (Consisting work order, Payment Certificate & Completion Certificate for a single work as mentioned above since last 5 (five) years which will be in the sealed envelope of Technical Bid.

And Bank Demand Draft in favour of the undersigned as Earnest Money has to be submitted in the envelope containing Financial Bid.

Both the envelop must be superscripted as Technical Bid and Financial Bid and will be in a big size envelope and superscripted thereof for NIT Number & Date and Work Sl. No. for which he / she applied for.

In case of the credential submitted of any Gram Panchayat, Signature of the Executive Assistant must be required along with the signature of the concerned Pradhan.

- Both the copies of the DCR & the Earnest Money in form of Bank Draft will be deposited in Favour of the Block Development Officer, Hirbandh Dev. Block from any Nationalized Bank along with the tender. The Bank Draft for the unsuccessful tenderer/s will be refund after issuance of the Work Order to the successful tenderer.
