

### 1. REGISTRATION OF CONTRACTOR

ANY CONTRACTOR WILLING TO TAKE PART IN THE PROCESS OF E-TENDERING WILL HAVE TO BE ENROLLED AND REGISTERED WITH THE GOVERNMENT E-PROCUREMENT SYSTEM, THROUGH LOGGING ON TO [HTTPS//ETENDER.WB.NIC.IN](https://etender.wb.nic.in). THE CONTRACTOR IS TO CLICK ON THE LINK FOR E-TENDERING SITE AS GIVEN ON THE WEB PORTAL.

### 2. DIGITAL SIGNATURE CERTIFICATE (DSC)


