During the brief description the following issues came under discussion and on spot direction were conveyed to the concerned.

4.	Identification of Sports Clubs.	The DPO Bandipora shall frame a committee consisting of following officials for identification of sports clubs and providing of sports equipment's: 1. Panchayat Inspector/VLW/MPW of RDD 2. Teacher/Head Teacher of Education. 3. PET/PEM of YSS.	ACD Bpr DPO Bpr. DYSSO Bpr, CEO Bpr
5.	Development of Play Fields where land is available	All the DBO's shall immediately start the work where land is available for development in the Panchayats without any further delay.	ACD Bpr /BDO's Concerned
6.	Development of Play Field at Kehnusa	The ACR Bandipora shall get the land identified at Kehnusa as agreed by him in the meeting for its further development through RDD.	ACR Bpr/ACD Bpr
7.	Dev. of play field at Ashtangoo & Khayar	The ACD Bpr, Xen REW shall frame the DPR for development of play fields at Khayar & Ashtangoo under KLC.	ACD Bpr. Xen REW Bpr.

All the concerned departments shall furnish the action taken report of each decision within weeks' time positively.
